Zero Carbon Bill –

- Consultation on the Zero Carbon Bill started on 17 June and runs until 19 July. Consultation includes a series of public meetings around the country. The consultation process acknowledges the importance of considering the unique characteristics, governance and collective ownership of Māori land, Māori aspirations, cultural values, and rights under the Treaty of Waitangi in facilitating the adoption and implementation of climate change opportunities. While the Government has not specifically modelled the impacts on Māori businesses or households, the response to climate change will affect Māori enterprises, particularly in the forestry, agriculture and fisheries industries, and workers in some areas. In addition, modelling shows that vulnerable households will be more affected, and a proportion of these will be Māori. Government is committed to ensuring a fair and inclusive transition, and Māori households will need to be considered.
- Climate change and the response to climate change are of great concern to some iwi/hapū/Māori groups. The Pou Taiao Iwi Leaders Group advised the previous and current Governments that climate change is a key kaupapa for iwi.
- The Minister for Climate Change, Hon James Shaw, and the Ministry for the Environment have undertaken a six week Zero Carbon Bill Consultation Hui for Climate Change. The key themes heard so far are:
 - A number of iwi have raised concerns about how to account for pre-1990 forests in the ETS, given that a significant portion of Maori-owned land is in forest
 - Questions have been raised about the social impact of the Zero Carbon on Maori communities
 - Concern over the impact on communities from increased forestry

Interest in how the Climate Commission is set-up so that it is enduring (removed from politics).

- Interest in the skill sets needed for the Commission and the need to represent Maori landowners
- A focus on the co-benefits (and inter-relatedness) of climate action on water, marine, forestry, society, wealth creation, trade, adaptation and leadership.
- Submissions for the ZCB will close 5 pm 19 July 2018.
