Apologies for the delay in our reply. We have been in contact with the team members that attended the regional hui in Taupō and they have replied with the following information:

Tina Porou and Tania Te Akau spoke at the Taupō hui on a suggested kaitiaki credit system (it does not currently exist). They discussed an existing example of Lake Taupō and water quality issues. Iwi take specific measures to responsibly manage their whenua alongside the lake and/or tributaries to support the water quality for the environmental and social good (ie. reducing stock numbers), however the neighbouring Pākehā farmers do not choose to. For the environmental good, their is an economical cost. The opportunity is a model that has kaitiaki/biodiversity credits for Māori, who are operating in a responsible way to support the ecosystem.

Note that Tania attended the final wananga with the Minister at Parliament.
