Thank you for your email of 29 May 2019 requesting the following under the Official Information Act 1982 (the Act):

- 1) Any briefings or Cabinet Papers sent between the Transition Hub and the Just Transition Unit at MBIE dated 2018, 2019;
- 2) Any briefings or Cabinet Papers prepared by the Transition Hub for Ministers and other Government departments dated 2018, 2019

We understand you have also requested this information from the Just Transitions Unit at the Ministry for Business, Innovation and Employment. We have accepted a partial transfer of that request, to cover any Cabinet Papers and briefings that were prepared by the Transition Hub. This is within scope of part 1 of this request.

The Ministry for the Environment has identified 37 documents in scope of your request, as listed in the attached table. Some information within these documents has been withheld or refused under the following sections of the Act:

- 9(2)(a) to protect the natural persons, including that of deceased natural persons
- 9(2)(b)(ii) to protect information where the making available of information would be likely unreasonably to prejudice the commercial position of the person who supplied or who is subject to the information
- 9(2)(f)(iv) to maintain the confidentiality of advice tendered to Ministers of the Crown and officials
- 18(d) that the information requested is or will soon be publically available

Where information has been refused under section 18(d) links to where you will be able to find these documents have been provided.

Under section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: www.ombudsman.parliament.nz.
