Thank you for your email of 1 July 2019 requesting the following under the Official Information Act 1982 (the Act):

Copies of any communications, including but not limited to presentations, hand-outs or other communications provided by Vicky Robertson and or MFE during her visit and attendance at EAT Stockholm.

Copies of any communications, including but not limited to emails inviting Vicky Robertson to EAT Stockholm. Please take this to include any emails to/from Professor Boyd Swinburn prior to or post attending EAT Stockholm.

The Ministry for the Environment has identified 21 documents in scope of your request, as listed in the attached table. Some information within one of these documents has been withheld under the following sections of the Act.

9(2)(a) to protect the privacy of natural persons

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

While the second part of your OIA request was for the invitation to Ms Robertson to attend EAT Stockholm, it was the Prime Minister and various government Ministers who were first invited. The Ministry for the Environment discussed the invitations with the Ministry for Foreign Affairs and Trade and the Ministry for Primary Industries then briefed Ministers. Agreement was reached that the Secretary for the Environment, Ms Vicky Robertson, would attend the event.

On the 3rd of July you sent a second OIA request relating to the EAT Stockholm event. That request is answered separately.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: <u>www.ombudsman.parliament.nz.</u>

Please note that due to the public interest in our work the Ministry for the Environment publishes responses to requests for official information on our website on our OIA responses page shortly after the response has been sent.
