

## Delivering your adaptation priorities through NAP objectives and actions

To deliver on your priority of strengthening New Zealand's ability to adapt to the effects of climate change, you have confirmed you are focused on:

## 1. Developing an Adaptation Framework and delivering the Adaptation Bill

## Each NAP must set out the:

- Government's objectives for adapting to the effects of climate change
- Government's strategies, policies and proposals for meeting those objectives (actions)
- the timeframes for implementing these actions (over the next six years).

Most of the actions you are responsible for are designed to meet the NAP's system-wide objectives.

But these objectives can be met in different ways... there are opportunities to adjust your actions to ensure they are both delivering on your priorities and meeting the relevant NAP objectives.
