Some maybe able to be accepted in kerbside recycling others may be problematic. Materials need to be able to be safely and effectively collected, sorted, and recycled. There is a balance between keeping messaging simple for the public and factoring in variations between different materials and products. The simple message of 'No lids' means glass lids are not accepted in kerbside recycling. However, as they are made of the same type of glass as the jar they probably could be.
