Overall Status - Key messages

Alternative schedule options have been developed this week and discussed at MfE Climate Change Governance Board. Next week they will be presented to the Minister and Cross-Agency Climate Change Directors. The project will considered on track once the schedule has been agreed by the Minister.

- A. Consultation concluded this week with public meetings/hui held in Tauranga (9 July), Rotorua (10 July) and Manakau (11 July). Additional meetings have also taken place with Te Arawa Lakes Trust (10 July). Responses remain generally supportive of the proposals in the ZCB. Questions are generally focused on the 2050 targets, emissions budgets and the Climate Change Commission (Commission) and the number of adaptation questions raised also increased. Questions this week included how the Governments is engaging with Pacific People and how the Commission will represent and engage with the social groups impacted by the Bill, including those living in poverty? A workshop is planned with the Federation of Māori Authorities (FOMA) (12 July).
- B. As of 9am on Friday 13 July 8,642 submissions have been received (up from 4,828 last week). Approximately 88% are form submissions. 8,563 (99%, up from 93% last week) submissions have been processed. Generation Zero, WWF, Forest & Bird, Project Jonah, Greenpeace and Ora Taiao NZ Climate and Health Council have form submissions. Submissions have been received from PCE, Wellington City Council, Greater Wellington Regional Council, South Taranaki District Council, the Independent Electricity Generators Association and Victoria University. Six individuals have identified themselves as Māori however no submissions have been received from iwi or Māori organisations.
- C. The final scope of the second round of modelling has been agreed by policy teams and approved by Managers. It includes: improvements to the approach to modelling 2050 emissions reduction targets, especially the Net Zero Long-lived Gases & Stabilise Short-lived Gases target; analysis of different stabilisation levels for short-lived gases, and considers the economic impact of the non-fungibility of short-lived gases (ie, where forestry is deemed to not be able to offset methane); improvements to the estimation of forestry in the model; further modelling to assess the economic impact of purchases of international emissions and; improvements to the estimation of emissions projections in the baseline model run. This is will now be implemented as a contract variation and work will commence immediately. The results from the modelling are due on 24 August and the final report on 17 September. During this period additional model runs/further sensitivity analysis will be undertaken if/where possible.
