Thanks for circulating this short-list. Just one comment from us. 9(2)(a) wasn't able to attend the whole discussion this morning but on his behalf is it possible to add 9(2)(a) to the shortlist? While other members of the shortlist have impressive Treaty expertise, 9(2)(a)'s background would create more confidence for iwi about the listed projects. He was nominated by Minister Potaka and confirmed his availability. Ministers will obviously have their own opportunities to put their nominees forward but we think the shortlist is more robust if he is included now.
