In response to your questions:

- Likely time commitment - we do not know at this stage and won't know until the application process is open and we see how many applications we receive. I should say two to four months would be a good starting figure, and I imagine it would take the form of reviewing time, then a series of meetings with other Panel members, then drafting of recommendations.
- Likely start date - we were aiming for the end of March, but it now looks more likely mid to end April (subject to a few process matters being landed)
- Remuneration details – We have applied for an exception to the Cabinet Fees framework so are aiming for around \$900-1200 per day depending on experience, \$1200-1600 for Chair
- Who else may be on the panel especially the Chair - Unfortunately, I am unable to disclose this information until Ministers have made their final decisions and we confirm the appointees sorry.
