Table 1 below shows the funding that was provided in Budget 2022 and then withdrawn in the mini Budget last year. The grey shaded rows match the functions covered by the Budget 2024 initiative below.

Table 1 does not capture the impact of the proposed Ministry for the Environment (MfE) savings target of \$49.1m annually or \$176.4m over four years.

Budget 2024 initiative comparisons

Table 2 captures the additional funding, and resulting FTEs, that would be available to support the delivery of the coalition government's (Resource Management Act (RMA) work programme and then effectively implement it and drive sustained change in culture and practice.

The preferred and scaled initiative both include time limited funding for three years to design and deliver change with reduced funding in the final year and outyears to embed changes in culture and practice.

Resulting total RMA funding including baseline (excl. effect of savings)

Table 3 shows what the funding above would provide on top of MfE's existing RMA baseline funding. Each row below, therefore, represents the new funding lines in Table 2 above plus the existing baseline.

That baseline RMA funding is approximately \$15m annually which would support 65 Full Time Equivalent (FTE) staff as shown in the bottom row below. This is the total resourcing that would be available if no new funding was provided in Budget 2024.
