#### Summary key messages

The Ministry for the Environment is preparing for significant changes in our workforce and work programme, as well as to third party funding, as a result of Budget 2024 decisions.

Below we've outlined specific areas impacted by savings, along with details of new funding for resource management reform replacement. Key context to note is:

- The savings come on top of the return of \$301 million (over four years) in RM implementation funding in the Mini Budget and an already declining baseline. The combined impact will see the loss of more than a third of our staff over the forecast period however this is subject to consultation.
- Shortly after Budget Day we will consult with staff on the implementation of the combined cost savings, with final decisions made once we've considered all feedback.
- We are also in the process of designing our business plan and work programme, and will bring prioritisation options to Ministers in June, reflecting our significantly reduced capacity.
- The net impact of savings required of Vote Environment since December, and new funding for RM Reform Replacement in the Budget is 21 percent—nearly three times the 7.5 percent savings target. This is due to minister choices about our eligible baseline, the return of funding in the mini budget, and additional targeted savings in waste.
- Savings to non-departmental initiatives will have significant implications for council-run, community and non-government organisations that rely on these to fund environmental activities. These are outlined in BRF – 4621 Adie Memoire.

### **Reduction in Back Office Functions - Ministry for the Environment**

This savings initiative returns \$22.253 million total operating funding for back office functions at the Ministry for the Environment to align with the Government's priorities.
