I just wanted to give a heads up that we are planning on sending over a draft CPMG pack for the Minister to review over the weekend. We will aim to have all of this to you on Friday. It is possible the slide deck for item 2 may need to be provided on Monday ahead of the meeting.

The draft items we will send over are:

- Draft agenda
- Item 1: climate approach/vision - one pager plus draft Cab paper.

Item 2: Short slide deck on ERP2. This will foreshadow the Cabinet paper coming next month, which will seek approval to consult on ERP2 via discussion document.

- Item 3: The Climate Board's quarterly report (TBC whether this is a noting paper only or item for discussion) - The update on government priorities part of the report won't available this week as we are still getting the necessary information from agencies. A separate briefing is being prepared on the interim projections sufficiency analysis and will also be provided on Friday (we will try to provide all of this together at the same time if we can). The intention is for this analysis to inform part of the Board's quarterly report.

We propose to use the 30 minutes otherwise allocated for ERP2 on Monday at 3pm on Monday to discuss the CPMG agenda, items and any direction from the Minister. We will also send an agenda for the Monday meeting with the draft pack.

Hi James,

Following on from our chat this morning, I have had a chat with those leading papers for the next CPMG and this is what we propose in terms of timings.

Agenda – we will aim to get you a draft agenda this week for you to take a look at. However, we would ask that this not be given to the Minister at this stage as MfE would like to have the Monday officials meeting first to land an approach to CPMG, including the agenda.

We will aim to have a draft pack for the Minister to review by the 3<sup>rd</sup> May. This will likely be the same time as the pack will go to the Climate IEB for sign out, so may need to be updated to reflect Board feedback. We are still confirming dates for the Board meeting. We also recommend the draft pack be provided to PMO at the same time so discussions between the two offices can occur as needed.

We will aim to get a final pack that includes MCC, PMO and Board feedback by the 10<sup>th</sup> May (i.e. before the Minister heads overseas). This is dependent on when we can get the Board meeting scheduled and the extent of feedback received. At this time the pack would be sent to all CPMG Ministers.

When the final pack is received MfE would also like to provide a draft of the ERP2 Cabinet paper and discussion document for MCC review. This would not be sent to other Ministers.
