I am releasing three of these documents to you in full.

I am releasing 13 of these documents to you in part, with some information withheld under the following sections of the Act:

- 6(a) to not prejudice the security or defence of New Zealand or the international relations of the Government of New Zealand.
- 9(2)(a) to protect the privacy of natural persons.
- 9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials.
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members

of an organisation or officers and employees of any public service agency or organisation in the course of their duty.

9(2)(h) to maintain legal professional privilege.

9(2)(j) to enable a Minister of the Crown or any public service agency or organisation holding the information to carry on, without prejudice or disadvantage, negotiations (including commercial and industrial negotiations).

18(d) as the information requested is publicly available.

Please note that the request to the Climate Change Commission for advice to support decisions on the second nationally determined contribution referenced in Documents 13, 14, and 16 was made under the previous government. The request has since been modified.
