I hope you're well. I just wanted to let you know that the SIRRL decision (waste to energy plant in Waimate) was decided today. Consent has been granted. This is confidential at this stage and will only become public when it's published on our website at the end of April (or unless it becomes public through the Applicant before then).

We included a condition around repairing the land to its current state. The Approved Feedstock condition has not been included but is expected to be regulated under the Environment Court process.
