Kia ora koutou,

You're receiving this email as you are on the invite list for the CNGP "Commuting & working from home" Community of Interest.

A small group of us have focused on methodologies for commuter surveys in recent months. Our aim has been to develop resources for CNGP agencies that can save time and avoid multiple agencies having to re-invent the wheel. We took stock of existing guidance (CNGP, Waka Kotahi, Councils) and methodologies used by agencies who have already measured commuting.

We then converged towards developing the following outputs:

- 1. A decision tool (<u>Commuter survey DRAFT decision tool August 2024.docx</u>) to help agencies work out the level of detail they wish to go for, and what to consider.
- 2. A simple survey template Version A (Survey template Version A DRAFT v2 May 2024.docx)
- 3. A more complex survey template Version B (<u>Survey template Version B DRAFT v2 August 2024.docx</u>)
- 4. A workbook containing calculations and assumptions to make analysis easy To be developed once the survey templates are firmed up.
