We hope the audit process is wrapping up smoothly for everyone. We have several important updates to share, so please read all the way through.

Change to MfE CNGP team

As everyone is acutely aware, the public sector is undergoing significant changes and restructuring. MfE has nearly finished its own restructuring, which will result in the disestablishment of the CNGP as a standalone team. However, from November all CNGP MfE functions will continue within two new teams, which will split the reporting/support, and policy components. You will have continuity in the MfE CNGP contact, as Sultana will be the lead for all reporting and implementation aspects of the programme moving forward. The existing CNGP inbox will remain active and is the best way to contact the MfE CNGP. Please be patient with us, as response times may increase due to staffing changes.

Briefing to Minister Watts

You may have seen recent media coverage regarding advice provided by MfE to Minister Watts concerning the CNGP's carbon neutrality goal. We can confirm that the Ministry has discussed options with the Minister, but no decisions have been brought to Cabinet at this time. Feedback from the Minister on a further briefing this month will guide our next steps for the programme, and we will keep you informed of any developments.

2024 Reporting

Please note that the online version of the survey will not be ready for you until 21 October. The data tool is updated with corrected names and processes pages for you to attach your documentation when you are ready. Please note we may not process your submission immediately.

Update on request for CNGP monitoring data

We contacted you recently regarding a request for CNGP monitoring data. Thank you to everyone who provided feedback on this request. Most organisations were supportive of the information being released but there were some concerns regarding the level of detail proposed. Our Ministerials team have subsequently advised that this request does not constitute an official information request, and we are now treating it as a data request. Our intention is to release a slightly less detailed dataset on our website. The original request was from data.govt.nz and we will be providing them with a link to this information.
