**Subject:** Update and short survey on the Carbon Neutral Government Programme

## Kia ora

The Government released its <u>climate strategy</u> in July this year, highlighting five core pillars that underscore its commitment to delivering on New Zealand's climate change objectives.

Following this, the Government released its <u>draft second emissions reduction</u> plan, highlighting key principles that will guide actions in the second emissions budget period (2026 – 2030). In particular, it outlines the Government would remove barriers to enable rapid investment that grows the economy and increases productivity, and that targets would be met by a mixture of actions that reduce our overall emissions alongside activities that remove greenhouse gas emissions.

This email is to update you on the role of the Carbon Neutral Government Programme and how it fits within the Government's broader strategy.

As a result of the Government's strategy and draft plan for emissions reductions, Climate Change Minister Simon Watts has requested advice on the programme's alignment with the Government's climate approach. This advice will inform if the programme should continue as is or if decisions are needed by Cabinet on future options for the programme.

As the Ministry for the Environment (MfE) provides advice to the Minister of Climate Change on the programme, we recommend agencies continue to focus on measuring, reporting and reducing their emissions in line with their own emissions reduction plans and reporting these to the MfE by 1 December 2024.
