I was seeking more information following a meeting between Grey District Mayor Tania Gibson, and Minister Hon Penny Simmons, where the Mayor raised her concerns about the landfill, and the potential risks it could pose to the Greymouth water supply.

Darryl provided me with an update about WCRC's proposed course of action for quantifying the potential risk to the water supply, and for resolving the compliance concerns about the activities occurring at Taylorville.
