1. Strategic priorities

1.1. Parliamentary Commissioner for the Environment (PCE) – release of the review of the Environmental Reporting system

The PCE has undertaken a review of the Environmental Reporting system. On 6 November he will hold embargoed briefings with the Ministry and other stakeholders. On 7 November at 2pm, he will release the findings at a press event at his office. We will be issuing a press release on 7 November (joint with Stats NZ), in support of the review.

The review is likely to comment on the roles and responsibilities under the Environmental Reporting Act 2015, its purpose and its framework, the cycle for reporting, and the data and science that supports Environmental Reporting. There will very likely be overlaps between the findings of this review and the review of the Resource Management system, particularly around environmental monitoring.

The Ministry and many other stakeholders were consulted during the review process

2. Actions and decisions

2.1. Announcing Community Environment Fund funding for Environment Hubs Aotearoa and Environment Centres

In 2018, you directed the Ministry for the Environment to work with Environment Hubs Aotearoa (EHA) to develop a centralised funding model for Environment Centres and to grow and support the network. In February we advised that this work will progress in two stages, to develop and then implement the model.

The Ministry currently funds nine Environment Centres through the Community Environment Fund. The intention is that in the future, the Ministry will have one funding deed with EHA, who will then manage the funding a rangements with Environment Centres.

We have now entered into a Deed of Funding with EHA for the first stage of this work. Stage 1 focuses on: building the capability and capacity of EHA and its members to support local environmental action; assessing and increasing EHA members' impact and community reach; and supporting carefully planned growth in EHA's role to facilitate Environment Centre funding and manage reporting. This Stage 1 project has not yet been announced. You may wish to announce this funding; otherwise please provide your approval for EHA to self-announce.

We expect EHA to provide the Ministry with a proposal for a centralised funding model in December. We are wo king closely with EHA to develop this proposal. The proposal may include a request to additional funding for Environment Centres.

In February 2020 we will seek a decision from you about progressing with Stage 2 of the work. At the same time we will provide advice on a new funding round for the Community Environment Fund.

3. Updates for noting

3.1. Meeting of Contracting Parties to the London Protocol, London Convention

A Ministry official attended the meeting of Contracting Parties to the London Convention and the London Protocol, from 7-11 October 2019.

A key decision was the adoption of the joint resolution from Norway and the Netherland's to provisionally apply the 2009 amendment to article 6 of the London Protocol. There was overwhelming support for the resolution that will allow states to transport CO_2 across boundaries for sequestration in sub-seabed geological formations. New Zealand participated in a drafting group on the proposed resolution, which further emphasised the importance of reducing greenhouse gas emissions and urged states to share information about agreements to transport CO_2 across boundaries.

Contracting parties were also provided the latest scientific information on marine geoengineering activities (including ocean fertilisation), updates on O_2 sequestration projects in Europe, and the work of the London Protocol as it relates to marine litter and microplastics. The delegation of Japan also updated the meeting on its treatment of contaminated water at the Fukushima Daiichi Nuclear Power Station.

3.2. Waste Management Fund – priority projects update

The following provides you with an update on the key Waste Minimisation Fund projects.

Golden Bay Cement (GBC)

The purpose of this project is to purchase and install infrastructure at the Golden Bay Cement (GBC) facility in Portland, Northland, capable of processing up to s 9(2)(b)(i), s 9(2) (b)(ii)

- GBC's Variation to the Deed of Funding is currently being reviewed. We hope to be able to track towards signing of the Variation by the end of the month.
- s 9(2)(b)(i), s 9(2)(b)(ii)
- all contracts with contractors have been finalised by GBC, allowing detailed designs to be finalised and early site works for the Pre-heater Tower to commence.
- s 9(2)(b)(i), s 9(2)(b)(ii) of tyre-derived fuel has been transported to Portland to ensure a sizable stockpile is onsite before the scheduled shutdown.

Waste Management (WM)

The purpose of the project is for Waste Management to set up a nationwide collection and processing operation for End-of-Life (EOL) tyres.

- WM has experienced lengthy delays since the opening of the Auckland tyre processing site in May 2018, primarily due to problems/issues encountered with customers and potential customers of tyre-derived fuel (TDF), \$9(2)(b)(i), \$9(2)(b)(ii)
- all the problems have now been resolved by WM through the contracting of a new South Korean TDF customer, the transport of TDF to Portland ahead of GBCs shutdown, and the acquisition of the required Christchurch property.
- last week, WM submitted their resource and building consents to Christchurch City Council for the Christchurch site (no full public consultation required), and hope to have feedback on the process in December.

• a Variation to the Deed of Funding is being worked on with the Ministry to realign the project milestone dates.

Ovea Premix - Gore District Council (GDC)

This project focuses on the removal and disposal of Ouvea Premix (a toxic, partially processed product sourced from dross, an oxide residue, and a hazardous waste by-product, created during the aluminium making process).

- Inalco commenced the removal process at the Mataura site on 9 October 2019. The process is expected to be slow initially with the assessment of the bulk bags.
- the Deed of Funding is close to being finalised. GDC are currently confirming with Inalco what documentation will be delivered to them during the removal and disposal process to ensure the documentation requirements required by the Ministry in the Project Plan are realistic.

3.3. Sustainable Finance Forum Interim Report released

On 31 October the Aotearoa Circle (which the Ministry is a founding partner of) released the first deliverable from its flagship project, the Sustainable Finance Forum (SFF)

The SFF brings together key players in New Zealand's financial system - including Māori leadership, representatives from banks, insurance companies, industry, professional services, civil society, academia, and government - to explore how to re-design our current financial system to meet the challenges and identify opportunities.

The aim of the SFF is to understand and provide recommendations on how to shift New Zealand to a sustainable financial system – from one which focuses primarily on (often short-term) financial wealth creation, to one that supports long-term social environmental, and economic wellbeing and prosperity for all New Zealanders, protecting natural resources for future generations. At the same time, this will strategically position New Ze land for continued access to international markets. The Roadmap will include specific recommendations on re-shaping the current financial policy, regulatory and market framework.

The Forum has produced an interim report (https://www.theaotearoacircle.nz/sustainablefinance) that explores the drivers and ba riers to a sustainable financial system and proposes focus areas and potential solutions.

The Forum is now inviting public feedback (until February 2020) on the interim report. Feedback will be used to strengthen a final report and roadmap for action due to be released in mid-2020. We are working on preparing a government response to this report. The Ministry has set up a cross agency working group to look at this.

A number of countries are also u dertaking a similar approach, including the European Union, the United Kingdom Canada, Luxembourg, China, Japan, Australia, Argentina, Chile, India, Kenya and Morocco, among others

2. Updates for noting

2.1 Single-use plastic shopping bag ban: compliance, monitoring and enforcement update

The ban on single-use plastic shopping bags took effect in New Zealand on 1 July 2019.

The Ministry is responsible for operational implementation and ongoing compliance, monitoring and enforcement of the ban. To date, an online portal has been developed to enable members of the public to report suspected breaches of the ban and the Ministry has been focussed on an educative approach to encouraging compliance.

As at 16 October 2019, the Ministry had received 308 reports of alleged breaches. This statistic was reported in a stuff.co.nz news article on 24 October 2019 titled 'Almost 150 bag ban breaches, zero consequences for retailers'. The Ministry has now received 335 reports of alleged breaches. A further breakdown of this number is provided in the attached infographic.

Officials will provide you further updates on the compliance assurance programme for audit, investigation and case management in relation to the ban as this work progresses.

2.2 Trends in levy spend reporting

Ministry officials are compiling the results of reporting from the Territorial Authorities (TA's) on their spending of the Waste Disposal Levy for the 2018/19 financial year. Half of the money collected through the Waste Disposal Levy is distributed to territorial authorities, to be spent on promoting or achieving the waste minimisation activities set out in their waste management and minimisation plans. TA's provide a report to the Ministry each year describing how levy money has been spent.

There are some challenges in collecting robust data around levy spending and measurable outcomes; for instance reporting is purely voluntary and there can be inconsistency in the way councils classify their spending (one council may report the purchase of new recycling bins as 'services', but another might report it as 'infrastructure').

The Ministry is working alongside TA's to increase the value of the data collected, starting with improvements to existing guidance material, and will provide updates in due course. Spending is organised into six categories for reporting purposes: infrastructure, services, education and communication, research and reporting and other initiatives.

Trends over the 17/18 financial year show that spending has been most heavily weighted towards 'services' (such as kerbside recycling collection and operating recovery facilities), followed by 'education and communication' (such as workshops on marge to educate about waste minimisation).

2.3 Information update regarding cigarette filters and plastics policy work

Minister Parker has expressed an interest on further information around plastic cigarette filter litter, including whether there is scope to move away from non-biodegradable filters. Cigarette filters are the most common form of human-made litter in the world and are predominantly comprised of cellulose acetate plastic. In the Ministry's *Marine Report 2019* cigarette filters were found to be the most abundant type of litter on beaches with the potential to cause harm to both the environment and marine life.

Our preliminary research suggests that no major tobacco company makes biodegradable cigarettes. One small start-up company in South Africa produces biodegradable cigarettes, with limited sales. No country appears to have banned single-use plastic-based cigarette filters. Other countries, such as England and Singapore, choose to reduce filter waste by having harder penalties and fines for littering. In Europe, Parliament has announced a ban, commencing in approximately 2021, on single-use plastic items such as plates, cutlery, straws and cotton bud sticks (cigarette filters were not included in this ban).

Currently, the Prime Minister's Chief Science Advisor is working on a report on plastics. This will advise multiple recommendations to reduce plastic waste and move Aotearoa toward a more sustainable relationship with plastics. The Government's response to that report is an opportunity to set out next steps in tackling NZ's plastic challenge, and could potentially include phasing out certain plastic products/items.

The Waste Minimisation Act already has provisions for the prohibition / phase out of specific produces (e.g. single use plastic bags).

2.4 Waste Levy Expansion – Communications and Stakeholder Engagement

We are in the process of finalising the Communications and Stakeholder Engagement Plan for the waste levy expansion. We are beginning to book tentative meetings with key stakeholders to discuss the levy expansion during the proposed consultation period. Your office has tentatively booked time in your calendar for a meeting with the Waste Advisory Board on Monday 25 November.

2.5 Regulated product stewardship: timeframe for Tyrewise proposal

At the weekly meeting on 4 November 2019, you raised a query around the completion of the tyre industry their Product Stewardship Scheme.

We note that there are unique challenges for that scheme. The tyre industry does not have an existing scheme in comparison with the Agrichemicals Recovery and Refrigerants Recovery (there has been no voluntary tyre product stewardship scheme in place since the closure of Tyretrack in 2008).

We also observe that the working group was approved in 2019 for a deed of funding to update the product stewardship proposal with current data. The updating process is on track for delivery in December 2019.

2.6 Update on Litter Projects Working Group

The Litter Projects Working Group (LPWG) met on 5 November 2019. It was attended by Ministry representatives and representatives of the three litter projects currently funded by the Waste Minimisation Fund (WMF). Sustainable Coastlines, Keep New Zealand Beautiful and the Packaging Forum are the lead organisations for their respective litter projects. These projects represent a funding commitment of up to \$7.4 million over three years. The Ministry chairs the working group as an "active observer" to ensure that the New Zealand public receives clear and consistent messages about litter in New Zealand.

The projects are working together collaboratively. A data governance group has been formed to ensure information sharing on data collection and use. The group has agreed to undertake a regional gap analysis to consider whether all communities across New Zealand have access to the different communication and environmental education resources. Collaboration on the launch of a recycling station by the Packaging Forum in Gisborne is being considered with Sustainable Coastlines.

The next meeting will be held in February 2020. The group has requested a discussion on options post-WMF funding. Synergies between projects and Ministry's priority work programme on regulated product stewardship, the container return scheme and the waste levy expansion are likely to be discussed.

The Ministry will provide you with an update after the next meeting to discuss further how the sustainability of litter activities can be ensured post the current WMF funding provided to these organisations.

2.7 Review of the Environmental Reporting System

The Parliamentary Commissioner for the Environment (PCE) released his review of the environmental reporting system on Thursday 7 November 2019.

In the review he recommended:

- a shift in environmental reporting system 'from passive to active information gathering', including the developmen of a 'comprehensive, nationally coordinated monitoring system'
- dedicated investment and funding is required over multiple years to back and maintain this system shift
- changes to the way that environmental reporting is done, including a six year reporting cycle
- changes and clarification of roles and responsibilities, including a role for the Government to formally respond to synthesis reports, i.e. commenting on the effectiveness o policies.

The PCE's review presents an opportunity to progress a system-wide conversation on improvements to the science and data system.

We will look further at the report over the next week to assess the path ahead.



1. Strategic priorities

1.1. Fortnightly update on the Container Return Scheme design project

The national Container Return Scheme (CRS) project has started well. You approved funding for the project deed on 4 November 2019 (briefing note 19-B-06168). Marlborough District Council (the recipient) and the Ministry have finalised and signed the deed. Auckland Council is also a funding sub recipient on this joint project.

The next key milestone is the Scheme Design Working Group commencement meeting on 27 November. The meeting will bring the group together for the first time. The group intends to finalise the project research scope, which will be the basis of the CRS design. Deputy Secretary Sam Buckle will attend the meeting. As you are unable to attend, the Ministry is preparing a letter of key messages from you, for your consideration, to be relayed at the meeting.

In accordance with the deed of funding, the project team will provide fortnightly updates on the project's progress. The first update (covering 4 - 15 November 2019) is attached to this weekly update. For future updates we will request the project team be more specific around timeframes and provide greater clarity around the risks and issues.

The CRS Technical Advisory Group (TAG) procurement process is well underway in order for the TAG Chair to attend the Scheme Design Working Group meeting.

The CRS Project Manager, George Fietje, will attend the Waste Advisory Board meeting on 25 November to brief the board (following your attendance at the meeting). The Project Manager will also meet with agency reference group representatives on 26 November.

Ministry officials plan to accompany the Project Manager and the Project Researcher on a tour of Australian schemes in December.

2. Updates for noting

2.1. Single use plastic bag ban - compliance update

You have requested an update on the Ministry's approach to compliance for the ban on single use plastic bags.

Our last update to you on 11 November noted that the Ministry had received 335 reports of alleged breaches. The number of reports received through our online portal now sits at 347.

In the five months since the ban entered into force, our focus has been on education; helping regulated businesses understand the intent and effect of the ban in order to achieve compliance. The Ministry is implementing a post-ban compliance assurance programme in 2020, which would involve having a Ministry staff member dedicated to carrying out proactive audits of retailers, investigating complaints and managing cases

While the Ministry's preference will always be to work with the regulated community to promote and encourage voluntary compliance, we are empowered by the Waste Minimisation Act to prosecute cases where the ban has been knowingly breached. If non-compliance was identified through audit and/or investigation, appropriate action would need to be decided on a case-by-case basis according to the issue and context.


We will provide further updates as work on a Ministry-led compliance assurance programme progresses.

2.2. Updated timings to implement the Basel decision on the trade in plastic waste

In May, Parties to the Basel Convention agreed to amend annexes to the Convention to better manage the international trade in plastic waste. The amendments will require exporters to receive the prior informed consent from importing countries before they can ship most mixed and/or contaminated plastic waste for recycling. We are currently drafting a consultation document on options to implement the Basel decision in New Zealand [2019-B-005919 refers].

We previously advised you and Minister Parker that the Basel Convention Depository was expected to notify Parties of the adoption of amendments to the Basel Convention in late 2019 – early 2020 [2019-B-005919 refers]. However, the Depository issued its notification earlier than expected.

The Basel decision will therefore enter into force on 24 March 2020 for all Parties that have not 'opted out' of the amendments. Opting out of the amendments requires Parties to notify the Depositary in writing by 24 March.



We will provide you with further advice by early February 2020, along with the consultation document and Cabinet paper.

The amendments will not become 'effective' until 1 January 2021. This is the date that New Zealand will be required to have implemented the amendments in order to comply.

2.3. Callaghan Innovation's 2019/20 C-Prize Programme

The Ministry has recently become a support partner to Callaghan Innovation's 2019/20 C-Prize Programme. This is part of our ongoing commitment to partner and support innovation that will help solve environmental challenges.

This is a non-financial arrangement with our role being to provide expertise and input, linked to what we know about the challenges we face highlighted in EA2019 and the issues we are trying to solve.

Entries are being sought from tech – based innovations linked to the New Zealand Governments environmental indicators, in the areas of climate change, clean water, and smart resource use

The three entry categories for this year's C-Prize are:

Growing and Producing: How we grow and/or manufacture new or existing products and services in innovative ways (new materials, new processes, new systems, etc.) that will accelerate positive environmental outcomes

Using and Consuming: How we consume products in ways that preserve resources (reuse, recycle, reclaim, etc.) and reduce negative environmental impacts

 Rejuvenating Natural Systems: The creation or innovative use of technologies that will not just reduce negative environmental impacts, but improve our natural environment (land, climate, soil, water, and nutrient systems)

The ten finalists then go through an agile development programme, including the provision of mentoring, product development support and measuring impact guidance. The winner will receive a \$150,000 prize package.

Entries for C-Prize are open until 8 December and finalists will be announced on 20 December.
