# FTC#139: Application for referred project under the COVID-19 Recovery (Fast-track Consenting) Act 2020 – Stage 1 decisions

#### Key messages

- This briefing seeks your initial decisions on an application from Build Rich Limited and Nation Shine Holdings Limited to refer the East Coast Heights-Silverdale Project (project) to an expert consenting panel (panel) under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (the FTCA).
- 2. The project is to subdivide a 10.6-hectare site located at 1 Silverwater Drive and 2150 East Coast Road, Silverdale, Auckland and construct approximately 303 residential units (26 of which may be constructed by third parties) and supporting infrastructure including roads, accessways and three-waters services. The project includes the restoration and planting of a natural wetland on the site and will involve earthworks extending onto small areas of the adjacent properties at 17, 39 and 53 Small Road, Silverdale.
- 3. The project comprises the third and fourth stages of a residential development being undertaken by the applicants between East Coast Road and State Highway 1 at Silverdale. Stages one and two lying immediately to the north of the project site are currently under construction.
- 4. The project will require subdivision and land use consents, and water and discharge permits under the Auckland Unitary Plan (AUP), and resource consents under the Resource Management (National Environmental Standard for Freshwater) Regulations 2020 (NES-F).
- 5. The land to be subdivided is in the Residential Mixed Housing Urban Zone and Sub-precinct B of the Silverdale 3 Precinct, under the AUP, while the neighbouring properties affected by earthworks are in the Business General Business Zone and Silverdale 2 Precinct. The purpose of Sub-precinct B of the Silverdale 3 Precinct is to enable a range of residential opportunities within a high-quality urban environment with a visually strong vegetated framework. The proposed activities have overall non-complying activity status due to the vegetation clearance and earthworks within 10 metres of, and diversion of water within 100 metres of, a natural wetland.
- 6. We have undertaken an initial (Stage 1) analysis of the referral application and this is presented along with our recommendations in Table A.
- 7. The project meets all the eligibility criteria in section 18(3) of the FTCA, but more analysis is needed before we can advise you if it meets the purpose of the FTCA (thus satisfying section 18(2) of the FTCA) and advise you on matters in section 23(5) which may influence your referral decision.
- 8. We recommend you progress consideration of the application to the next stage of analysis (Stage 2) and invite comments from Auckland Council and specific Ministers listed in section 21(6) of the FTCA.
- 9. We recommend you invite comments from the Associate Minister for the Environment (urban policy) as an additional Minister under section 21(6)(n) of the FTCA, and Watercare Services Limited, Auckland Transport and Waka Kotahi NZ Transport Agency as additional parties under section 21(3) of the FTCA.
- 10. We also recommend that you request further information from the applicants as detailed in Table A.

#### Statutory framework summary

- 11. You are the sole decision maker for the referral application as the project will not occur in the coastal marine area.
- 12. You may decline the referral application before seeking comments from the relevant local authorities and any relevant Ministers:
  - a. if you are satisfied the project does not meet the referral criteria in section 18 of the FTCA, (which include helping to achieve the purpose of the FTCA) (see sections 18(2) and 23(1) of the FTCA)
  - b. for any other reason (see section 23(2) of the FTCA).
- 13. If you do not decline the referral application at this stage:
  - a. you must provide the application to, and invite comments from, the relevant local authorities and the relevant Ministers prescribed by section 21(6) of the FTCA
  - b. you may provide the application to and invite comments from any other person.
- 14. You are also able to request further information from the applicants or any relevant local authority at any time before you decide to decline or accept the referral application (see section 22 of the FTCA).

At this stage we do not have any concerns about the applicants' ability to finance the project.	Based on available information at this stage, we consider the project is eligible for referral because:  • it does not include any prohibited activities  • it does not include land returned under a Treaty settlement  • it does not occur in a customary marine title area or protected customary rights area under the Marine and Coastal Area (Takutai Moana) Act 2011.	Based on the information provided by the applicants we consider the project may result in the following economic benefits:  • provide approximately 740 direct full time equivalent (FTE) jobs over a 5-year design and construction period  • contribute approximately \$172 million to regional GDP, and \$232 million to national GDP.	The project has the potential for positive effects on the social wellbeing of current and future generations as it will:  • generate employment by providing approximately 740 direct FTE jobs over a 5-year period  • increase housing supply through the construction of approximately 303 residential units in a range of typologies.	The applicants consider that the fast-track process will allow the project to progress approximately 12-18 months faster than under standard Resource Management Act 1991 (RMA) processes, by avoiding the delays associated with Auckland Council's consenting processes.  We recommend requesting further information from the applicants to support their statement and seeking comment from Auckland Council on the appropriateness of using the FTCA process.	Based on the information provided by the applicants we consider that the project may result in the following public benefits:  • generating employment  • increasing housing supply  • restoring a natural wetland.	The applicants have advised that the project has the potential for adverse environmental effects arising from:  • earthworks • stormwater disposal • construction activities (including traffic, noise and vibration) • works affecting vegetation and a natural wetland (ecological effects) and may include adverse effects on:  • visual, amenity, urban design and neighbourhood character • existing infrastructure, including the road network.  The applicants have provided a number of preliminary technical assessments in support of their view that the project will not have any significant adverse effects.  We note that you do not require a full Assessment of Environment Effects and supporting evidence to make a referral decision and a panel can consider this and any appropriate mitigation, offsetting or compensation to manage adverse effects of the development.	Other matters relate to: the applicants' ability to deliver the project in a timely manner; the ability to access all the land affected by the project; and the possible need for Overseas Investment Office (OIO) approval.  One of the applicants owns the land at 1 Silverwater Drive. 2150 East Coast Road is owned by Yang and Ho Limited, a company that is under the control of a director of Build Rich Limited. The ultimate holding company for both Build Rich Limited and Nation Shine Holdings Limited is registered overseas. The applicants have a sales and purchase agreement in place for 53 Smalls Road.  The applicants have an agreement with the owner of 39 Small Road to complete the necessary earthworks on their land, which involves construction of a road to vest to Auckland Council. They also have an infrastructure funding agreement for 17 Small Road.  There are some outstanding matters in regards to the titles for the project site that we recommend you clarify with the applicant.  On 7 June 2022 we sent a request for further information to the applicants, which included seeking clarification on whether any OIO approvals were required for the project. The applicants stated they have obtained OIO approval, and we recommend you seek further information, specifically the certificate of OIO approval.
