# Adaptation framework: draft Cabinet paper for Ministerial consultation

# **Key messages**

- 1. Following discussion with you on 7 March, we have updated the Cabinet paper (Appendix 1) on the adaptation framework and Select Committee inquiry.
- 2. The Cabinet paper seeks agreement on the scope, objectives, work programme and timeframes for the adaptation framework. It also seeks agreement to debate a motion in the House on the commencement of a Finance and Expenditure Committee inquiry into adaptation, and transfer of submissions from the Environment Committee inquiry into climate adaptation to this Committee.
- 3. We recommend the draft Cabinet paper is circulated to your Ministerial colleagues on 12 March, with feedback due on 19 March. Following integration of feedback from Ministerial consultation and your approval, we will work with your office to lodge the Cabinet paper on Thursday 21 March.
- 4. This briefing also provides advice on establishing the Ministerial Advisory Group (MAG) which will support development of policy for the adaptation framework. This advice includes: a draft Terms of Reference which includes the skills, expertise and knowledge requirements for the Chair and members of the MAG, the appointments process, timelines, fees and other costs projected for the group.
- 5. We recommend you seek nominations from your coalition party colleagues for the MAG alongside seeking feedback on the draft Cabinet paper.
- 6. The draft Cabinet paper signals the intention to establish the MAG and will be followed by a separate Cabinet paper regarding appointments. We will brief you on recommended candidates on 28 March for your feedback ahead of lodging that Cabinet paper.

# Adaptation framework: draft Cabinet paper for Ministerial consultation

#### **Purpose**

- 1. This briefing provides you with a draft Cabinet paper to circulate to your colleagues for Ministerial consultation.
- 2. It also provides you with advice on establishment of the Ministerial Advisory Group (MAG), to support development of policy for the adaptation framework.

## **Background**

- 3. You received a draft Cabinet paper outline [BRF-4369 refers] on 6 March, for discussion with officials on 7 March. In this discussion you:
  - i provided feedback on the outline, which has been addressed in the Cabinet paper (Appendix 1) as summarised in Table 1 below
  - ii set out your preference to progress the Select Committee inquiry via the Finance and Expenditure Committee (FEC), following consultation with your colleagues as requested by the Cabinet Legislation Committee (LEG) [LEG-24-MIN-0001 refers]
  - iii set out your preference to establish the MAG and clarified the purpose of the group.
- 4. The attached Cabinet paper will act as the report-back requested by LEG on 15 February.
- 5. We understand that the purpose of the MAG would remain as described in our briefing to you of 2 February [BRF-4148 refers], namely:
  - to test ideas and hear challenges with the current legislative framework experienced by sectors directly impacted by climate change, including Treaty partners, banking, insurance, and local government
  - to be involved in a series of deep dives on particular topics alongside other external parties.
- 6. In the meeting on 7 March, you also noted the MAG should consider how policy developed under the adaptation framework would practically work on the ground, and whether there are key elements that are missing or out of scope. We understand from previous conversations that you would like the MAG to advise and be a sounding board for adaptation framework policy, reporting directly to you with support from the Ministry for the Environment (MfE) as Secretariat.
- 7. On 7 March we also discussed membership of the MAG with you, based on the update provided in BRF-4369. We discussed possible gaps in local government membership for the MAG and officials advised that a call for nominations might address this.

# Analysis and advice

#### Cabinet paper content

- 8. Appendix 1 sets out the draft Cabinet paper on the adaptation framework and Select Committee inquiry for your feedback and for circulation for Ministerial consultation.
- 9. We have updated the Cabinet paper following your feedback on the outline [BRF-4369 refers]. We have included discussion on the MAG, Select Committee inquiry and a timeline. Table 1 outlines where we have made changes based on feedback from you and agencies.

Agency views not directly reflected in the paper

- 10. Agencies have contributed useful commentary on the aims and scope of the work programme. Many of these questions we consider can be further explored in the detailed development of the four workstreams, particularly as they relate to matters that may not be directly covered by the legislation.
- 11. Several agencies commented on managed retreat as a key known policy gap and flagged strategic questions around the Government's role in enabling retreat (covering a spectrum of options) that may need to be landed in advance of a cost-sharing conversation.
- 12. Agencies have signalled a need for more clarity on what parts of the existing system the principles of the adaptation framework would seek to influence.
- 13. They also underscored the need to focus on the policy problems where there are big trade-offs or benefits, and the need to actively manage potentially competing priorities (eg, going for Housing Growth) throughout the development of the framework.
- 14. You may receive feedback along these lines through Ministerial consultation. These concerns are partially mitigated by the in-principle nature of the decisions being sought through your Cabinet paper and the intention to involve agencies throughout the policy development process.

## **Adaptation framework**

Objectives and principles

- 15. The Cabinet paper includes a set of objectives, which are intended to guide the policy work to develop the adaptation framework. It is useful to have objectives agreed by Cabinet, as they will be used to assess and compare options during the policy development process. This is an approach taken by other reform programmes.
- 16. The objectives may be similar to, but are separate from, the decision-making principles which would be set out in adaptation legislation. Those principles should be developed as part of the adaptation framework work programme, including through input from the MAG, rather than seeking Cabinet decisions on the principles at this time.

# **Select Committee inquiry**

- 17. There are three main ways that you can influence the inquiry:
  - i notice of motion
  - ii Terms of Reference (TOR)

- iii initial briefing to the Select Committee.
- 18. We recommend the TOR for the new inquiry are included in the notice of motion rather than allowing the FEC to set its own TOR. The draft TOR are appended to the draft Cabinet paper (see Appendix A in Appendix 1 to this briefing).
- 19. We will work with your office and the Office of the Clerk to draft the notice of motion following Cabinet approval.
- 20. The notice of motion will instruct the FEC to undertake an inquiry into adaptation. It will also instruct the transition of the submissions from the Environment Committee (EC) inquiry into climate adaptation to the FEC.
- 21. As the submissions to the EC inquiry had a different scope than the proposed FEC inquiry, we recommend the following approach:
  - the initial briefing provided by officials to the FEC inquiry could provide a full summary of EC inquiry submissions, with a cover note advising which elements of the submissions are relevant to the new inquiry TOR
  - ii the TOR could suggest the FEC publish the summary of submissions from the EC inquiry as part of the proposed interim report.
- 22. This would provide submitters with assurance that their submissions have been considered and would do so at an earlier stage compared with the default approach of publishing the submissions summary at the end of the inquiry process.
- 23. The FEC may wish to call for new submissions based on the new inquiry's TOR. The FEC could choose to integrate elements of the new inquiry into the interim report.
- 24. The final report of the FEC inquiry could be based solely on the new TOR.

# **Ministerial Advisory Group**

Terms of Reference and skillset

25. When establishing a Ministerially-appointed group such as the MAG, there are key steps to be followed to support consideration by Cabinet. This briefing provides advice to ensure progress is made on these steps as quickly as possible. An initial step is to evaluate nominations to the MAG against a defined set of skills, experience, and knowledge, informed by the MAG's proposed TOR. In order to complete this step, we seek your approval of the TOR (Appendix 2).

#### Nominations process

- 26. We propose to seek nominations for MAG membership from the following groups:
  - New Zealand Banking Association, Insurance Council of New Zealand and Local Government New Zealand as they are likely to have a very strong interest in the membership proposed due to the experience sought in banking, insurance and local government.
  - Government agencies involved in the adaptation framework work programme (the Treasury, Ministry for Housing and Urban Development, National Emergency

- Management Agency, Department of Prime Minister and Cabinet, Department of Internal Affairs and the Ministry for Business, Innovation and Employment).
- Government agencies to support diversity of membership (Ministry for Women, Ministry for Pacific Peoples, Ministry of Disabled People, Te Puni K\u00f6kiri and Ministry for Ethnic Communities).
- 27. We also recommend that you seek nominations from the National, Act and NZ First parties.

Costs associated with the Group

- 28. For the TOR and the skillset proposed, we evaluated that the MAG would fall under Group 4, level 2 of the Cabinet Fees Framework. We propose to set fees at the higher end of the range for this level to attract the most suitable candidates. The daily fees would be \$974 for the Chair, and \$616 for members.
- 29. The MAG operating costs will vary depending on agreed meeting arrangements. Table 2 below provides you with estimated costs and CO<sub>2</sub> emissions for a range of high-level assumptions. In preparing these estimates, we assumed that half the MAG membership would be located in the Wellington region, and the other half would be based outside of Wellington. To simplify the calculations, we have assumed those members would be based in Auckland.

#### Other considerations

#### Consultation and engagement

30. The Cyclone Recovery Unit and Critical Infrastructure Resilience Unit (Department of Prime Minister and Cabinet), the Treasury, the Department of Internal Affairs, the Ministry of Housing and Urban Development and the National Emergency Management Agency were consulted on the draft outline of the Cabinet paper. These agencies and key additional agencies will be consulted on the Cabinet paper concurrently with Ministerial consultation.

#### **Risks and mitigations**

#### Select Committee inquiry

- 31. We understand that you would like final policy decisions on elements of the adaptation framework for legislation to be made in October this year. The final report of the FEC inquiry into adaptation will need to be published in September if it is to influence these decisions. This means the FEC will have just over 4 months to conduct the inquiry.
- 32. If the FEC faces challenges in managing its workload, for example due to receiving a large number of new submissions, there is a risk that the FEC will delay their report-back to the House. This could have flow-on impacts on the timeline for introduction of the Bill.
- 33. This risk can be mitigated through regular discussions between yourself and the Chair of the FEC. As the inquiry progresses, if it appears the FEC will not meet the desired timeframes, we will provide you with options for how to proceed.
- 34. There is also a risk that submitters whose submission (or parts thereof) to the EC are outside the scope of the new inquiry may feel their submissions have not been heard properly. This could be mitigated through the summary of submissions document proposed for release as part of the FEC's interim report.

#### Ministerial Advisory Group

- 35. We understand that one of your aims for establishing the MAG is to broaden the external perspectives considered during the policy process, supporting a consensus building approach to the adaptation framework. A systematic approach to seeking nominations can help to ensure the membership of the group has broad recognition.
- 36. You can mitigate the risk of any gaps and any reputational risk to you by undertaking a short call for nominations with a targeted group of Ministerial and Parliamentary colleagues, government agencies, and key partners and stakeholder groups, as proposed in paragraph 26 above.
- 37. Note that any recommended MAG candidates will be subject to due diligence checks and conflicts of interest will need to be declared and mitigated as necessary.

## Legal issues

38. No legal issues are associated with the proposals in this briefing.

# Financial, regulatory and legislative implications

- 39. There are no regulatory or legislative implications associated with the proposals in this briefing, beyond the intention to develop legislation through the adaptation framework work programme as described in the attached Cabinet paper.
- 40. The establishment and operations of the MAG will have financial implications for MfE, who will need to cover for fees and expenses of the group as part of existing FY23/24 budget and will need to ensure budget is allocated through business planning for FY24/25. Officials will conduct an internal funding approval process to secure the necessary funds. Depending on the final specifications of the MAG, we estimate these costs to be between \$8,000 and \$175,000.

## **Next steps**

- 41. The key actions for you from this brief are:
  - i approving the Cabinet paper for Ministerial consultation
  - ii seeking nominations for the MAG from National, Act and NZ First parties.
- 42. We propose the following next steps based on discussions with you and your office:
