Key messages

- This briefing provides you with final materials for your 15 October meeting with Ministers Willis, Bishop, Brown, Mitchell and Jones, and Parliamentary Under-Secretary Court, and the Adaptation Framework Independent Reference Group (IRG).
- 2. As noted in our previous briefing to you on 2 October [BRF-5375 refers], the purpose of this meeting is to discuss the adaptation framework work programme, including what decisions need to be made following the completion of the Finance and Expenditure Committee (FEC) inquiry into climate adaptation, any key risks and issues, and how this work can be supported by related work in your portfolios.
- 3. We have updated the meeting materials based on your feedback. Materials to forward to attending Ministers include:

BRF-5398 Adaptation framework: Final materials for 15 October ministers' meeting

Purpose

1. This briefing provides you with final materials for your 15 October meeting on the adaptation framework

Background

- 2. On 15 October you are meeting with Ministers Willis, Bishop, Mitchell, Brown and Jones, Parliamentary Under-Secretary Court and the IRG.to discuss the adaptation framework work programme. This will focus primarily on the advice of the IRG, and provide opportunity to discuss any key risks and issues, and how this work can be supported by related work in your portfolio
- 3. On 7 October we discussed the scope of a November Cabinet paper with you. You confirmed your preference for a high-level paper that is focused on seeking agreement to the Government responses for the FEC and Climate Change Commission's (CCC) reports, as well as indicate next steps for the development of adaptation framework. We provide a draft of this paper to you next week.

Meeting materials

- 4. You received draft materials for the 15 October meeting on 2 October [BRF-5375 refers]. This included an annotated agenda, a summary of the FEC recommendations and IRG's advice and a figure showing how the adaptation framework relates to other government work programmes.
- 5. Officials have updated the annotated agenda (Appendix 1) based on your feedback to include the 4 pillars of the adaptation framework and update the approach to reach final policy decisions in Quarters 1 and 2 next year.
- 6. The summary of IRG's proposed approach (Appendix 2) has also been updated based

on your written feedback on BRF-5375, namely:

4.2 Codified approach of relocation assistance postevent for houses declining from significant to zero, with flexibility to adjust to prevailing economic conditions

There needs to be reference to the hierarchy of options, before getting to managed retreat.

Updated to: Where relocation is identified as the most cost-effective option for houses after an extreme weather event, there is a codified approach of Crown assistance which declines from significant to zero over time, with flexibility to adjust to prevailing economic conditions.

Update to show relocation

Next steps

- 8. Officials will send you a draft version of the Cabinet paper attaching the proposed Government responses to the FEC and CCC reports on 17 October for your feedback.
- The Department of Prime Minister and Cabinet have advised that the Government responses should be approved by the Cabinet Legislation Committee (LEG) which is on 14 October rather than Cabinet Economic Policy Committee.
