FTC#159: Application for referred project under the COVID-19 Recovery (Fast-track Consenting) Act 2020 – Stage 1 decisions

Key messages

- 1. This briefing seeks your initial decisions on an application from Evans Family Trust to refer the Pohutukawa Drive Subdivision Project (project) to an expert consenting panel (panel) under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (the FTCA).
- 2. The project is to subdivide a 12-hectare site in three stages and construct a housing development at 996 State Highway 2, Eskdale, Hawke's Bay. The project will create 81 residential lots and 1 commercial lot and will provide 83 residential units (81 standalone homes and 2 apartments above the commercial floorspace). The application includes realigning the Whirinaki Drain, constructing a wastewater treatment plant, and a 2-hectare solar farm over the wastewater discharge fields. It is intended that the wastewater treatment plant is powered by the solar farm.
- 3. The project will require land use and subdivision consents under the partially operative Hastings District Plan; land use consents and discharge and water permits under the Regional Resource Management Plan for Hawkes Bay, and coastal permits under the Hawkes Bay Regional Coastal Environment Plan.
- 4. The proposed activities would have overall non-complying activity status due to exceedances of permitted standards, including subdivision within the Rural Zone to provide residential-size lots and the construction of buildings within a River Hazard Overlay.
- 5. Additional resource consent may be required under the National Environmental Standards for Freshwater 2020 (NES-F) as the project area contains a potential wetland which is within 100 metres of the 'proposed raingarden stormwater settlement area'. If the wetland is deemed to be 'natural', any discharge of stormwater within 100 metres of its limit is a non-complying activity. We recommend seeking further information from the applicant and the Hawke's Bay Regional Council (HBRC) on the nature of this wetland.
- 6. While the project site is not located immediately adjacent to the coast, it may be subject to coastal inundation and flood hazards. We provide further detail on this matter in Table A, and recommend that you seek further information on this matter from HBRC and HDC.
- 7. We have undertaken an initial (Stage 1) analysis of the referral application, and this is presented along with our recommendations in Table A.
- 8. The project meets all the eligibility criteria in section 18(3) of the FTCA, but more analysis is needed before we can advise you if they meet the purpose of the FTCA (thus satisfying section 18(2) of the FTCA) and advise you on matters in section 23(5) which may influence your referral decision.
- We recommend you progress consideration of the application to the next stage of analysis (Stage 2) and invite comments from Hastings District Council (HDC), HBRC and specific Ministers listed in section 21(6) of the FTCA.
- 10. We recommend that you invite comments from Associate Minister for the Environment (urban policy) as an additional Minister under section 21(6)(n).
- 11. We also recommend you request further information from the applicant as detailed in Table A.

Statutory framework summary

- 12. You are the sole decision maker for the referral application as the project will not occur in the coastal marine area.
- 13. You may decline the referral application before seeking comments from the relevant local authorities and any relevant Ministers:
 - a. if you are satisfied the project does not meet the referral criteria in section 18 of the FTCA, (which include helping to achieve the purpose of the FTCA) (see sections 18(2) and 23(1) of the FTCA)
 - b. for any other reason (see section 23(2) of the FTCA).
- 14. If you do not decline the referral application at this stage:
 - a. you must provide the application to, and invite comments from, the relevant local authorities and the relevant Ministers prescribed by section 21(6) of the FTCA
 - b. you may provide the application to and invite comments from any other person.
- 15. You are also able to request further information from the applicant or any relevant local authority at any time before you decide to decline or accept the referral application (see section 22 of the FTCA).

The project will require land use and subdivision consents under the partially operative Hastings District Plan; land use consents and discharge and water permits under the Regional Resource Management Plan for Hawkes Bay, and coastal permits under the Hawkes Bay Regional	The applicant has advised that it owns the land and that provisional arrangements between the applicant and their bank are in place for commercial lending to finance Stages 1 and 2, with the profit from these stages financing Stage 3. The applicant has previously completed two subdivisions (forming the existing Pohutukawa Drive) and are aware of finance and wider development requirements. Based on the information provided, we do not have any concerns over funding or project delivery at this time.	 Based on available information at this stage, we consider the project is eligible for referral because: it does not include any prohibited activities (see additional note below) it does not include land returned under a Treaty settlement it does not occur in a customary marine title area or protected customary rights area under the Marine and Coastal Area (Takutai Moana) Act 2011. Note: While not a prohibited activity, resource consent under the NES-F may be required if the wetland, which is within 100 metres of the 'raingarden stormwater settlement area', is determined to be 'natural'. 	Based on the information provided by the applicant we consider that the project may result in the following economic benefits: • creating approximately 147 direct full- time equivalent (FTE) jobs over a 4-year period (37 jobs per year) • contributing approximately \$19.5 million to construction sector GDP.	The project has the potential for positive effects on social wellbeing of current and future generations as it will: • generate employment by providing 147 direct full- time equivalent (FTE) jobs over a 4-year period (37 jobs per year) • increase housing supply by enabling 83 residential units.	The applicant estimates that under standard Resource Management Act 1 1991(RMA) process it may take up to 2.5 years longer to gain consent for the project due to the likelihood of notification and possible appeals. The applicant has also stated that the preferred approach of Hastings District Council (HDC) is for large subdivision schemes to go through a plan change process. The applicant estimates that this process may take up to 3.5 years longer than the FTCA process. The project has the potential for adverse environmental effects arising from: • earthworks • construction activities • increased loading on water supply infrastructure • traffic • loss of potentially productive rural land • impact on the character and amenity of the surrounding area The applicant has stated that the project will not have significant adverse effects. We note that you do not require a full Assessment of Environment Effects and supporting evidence to make a referral decision, and a panel can consider this and any appropriate mitigation, offsetting or compensation to manage adverse effects of the development. The project site is located close (but not immediately adjacent) to the coast and may be subject to coastal inundation. To mitigate this the applicant proposes to raise the ground level prior to undertaking construction, and to realign the Whirinaki Drain. We recommend that you seek comment	The proposed activities have overall non-complying activity status due to including subdivision within the Rural Zone to provide residential size lots and the construction of new homes within a River Hazard Overlay. The project area contains a potential wetland, and the discharge of stormwater from the 'proposed raingarden stormwater settlement area' is within 100 metres of the wetland area. The applicant states that the wetland is not natural and therefore not subject to the non-complying activity status under Regulation 54 (c) of the Resource Management (National Environmental Standards for Freshwater) Regulations 2020 (NES-F). The applicant has suggested commissioning an investigation by a wetland area. Resource consent under the NES-F may be required if the wetland is deemed to be 'natural'. We recommend that you seek additional information from the	 a. The applicant will liaise with HDC to have the conditions cancelled. We recommend that you seek information about the consent notices from HDC.
