Thank you for your email of 15 March 2024 requesting the following under the Official Information Act 1982 (the Act):

I would like to examine the 'materials' referred to in the judgment that were made available to the Minister and any others that perhaps were not provided to the court– i.e. any briefing note, aide memoir etc from officials regarding the ETS settings, early drafts and instructions from the Minister on this subject.

In addition, I would also ask whether officials agree that the materials were deficient and whether they take responsibility.

The Ministry for the Environment has identified 19 documents in scope of your request, as listed in the attached table.

Four documents have been provided to you in full. Two documents have been refused under section 18(d) of the Act, as they are publicly available.

One document has been withheld in full under section 9(2)(g)(i) of the Act, to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation.

Some information within 12 of these documents has been withheld under the following sections of the Act:

- 9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials.
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any public service agency or organisation in the course of their duty.
- 9(2)(h) to maintain legal professional privilege.
- 18(d) as the information is publicly available.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: www.ombudsman.parliament.nz.
