Dear 9(2)(a)

Thank you for your email of 22 March 2024 requesting the following under the Official Information Act 1982 (the Act):

Am researching the land in Wanaka known as sticky forest, which is owned by the crown and will eventually be transferred to the identified Maori successors according to the Ngāi Tahu treaty settlement of 1998. An application to rezone this land is also the subject of a current environment court appeal...

...so I request under the OIA any correspondence/reports/memos/documents from within the ministry between officials and to the then minister about the land known as sticky forest, or about the Winton property limited proposal for a retirement village (Northbrooke Wanaka Retirement Village), from Jan 1 to Oct 31 2020, including anything indicating when the WLP proposal first came to the ministry's attention.

I am refusing your request for 'reports/memos/documents' under section 18(d) of the Act, as the information requested is publicly available.

The Ministry for the Environment (the Ministry) has proactively released all application and decision documents for Northbrook Wanaka Retirement Village. These documents can be accessed here: <u>environment.govt.nz/what-government-is-doing/areas-of-work/fast-track-consenting/northbrook-wanaka-retirement-village/proactive-release-of-application-and-decision-documents/</u>.

Regarding your request for 'correspondence', there are twelve emails in scope of your request. Some information within these documents has been withheld under section 9(2)(a) of the Act, to protect the privacy of natural persons. Some information has also been withheld where it is out of scope of your request.

Please note the Ministry has excluded any emails that are administrative in nature, such as:

- Emails sending formal documentation that is already publicly available,
- Emails organising meeting times, or reviews of documents, and
- Emails discussing fast track consenting in a wider context, where the Northbrook Wanaka Retirement Village application is not discussed substantively.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: www.ombudsman.parliament.nz.
