

Tēnā koe ^{9(2)(a)},

Thank you for your email of 8 April 2024 to the Ministry for the Environment (the Ministry) requesting the following under the Official Information Act 1982 (the Act):

All feedback received by MfE on this matter [Targeted engagement on the proposed suspension of identification of new areas of native biodiversity]

The Ministry has identified eight documents in scope of your request, as listed in the attached document schedule. I am releasing seven documents to you in full.

I am releasing the contents of one document to you as a summary, as provided for by section 16(1)(e) of the Act. Some information from this document has been withheld under section 9(2)(ba)(i) of the Act to protect information which is subject to an obligation of confidence or which any person has been or could be compelled to provide under the authority of any enactment, where the making available of the information would be likely to prejudice the supply of similar information, or information from the same source, and it is in the public interest that such information should continue to be supplied.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: www.ombudsman.parliament.nz.
