I refer to your request under the Official Information Act 1982 (the Act), which was partially transferred from the Office of the Minister Responsible for RMA Reform, Hon Chris Bishop, to the Ministry for the Environment (the Ministry) on 7 May 2024. The Ministry is providing a response to the part of your request seeking the following papers:

- Advice on meeting invitations (12/01/2024)
- Fast-Track consenting follow-up (12/01/2024)
- A permanent fast-track consenting regime for regional and national projects of significance (16/01/2024)
- 100-day plan commitment: How to cease implementation of new Significant Natural Areas (31/01/2024)

- Briefing: National Direction for Natural Hazards: Next Steps (9/02/2024)

Of the 14 requested papers, four of these substantive papers have an associated appendix. Therefore, in total, the Ministry has identified 18 documents in scope of your request, as listed in the attached document schedule.

- One document has been released in part, with some information withheld under section 9(2)(h) of the Act to maintain legal professional privilege.
- Seven documents have been withheld in full under the following sections of the Act:

- Section 9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and official.
- Section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation.
- Section 9(2)(h) to maintain legal professional privilege.
- 10 documents have been refused under section 18(d) of the Act, as the information is, or is soon to be, publicly available.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: www.ombudsman.parliament.nz.
