Thank you for your request of 23 July 2024 to the Ministry of the Environment (the Ministry) under the Official Information Act 1982 (the Act) requesting the following:

*All written advice provided to Ministers from LINZ on the draft second Emissions Reduction Plan, including advice on:*

- *Policies that were included in the draft plan*
- *Policies that weren't included in the draft plan, and*
- *Previous policies or work programmes from the first Emissions Reduction Plan that were stopped.*

The Ministry is proactively releasing 44 documents containing advice to Ministers on the second emissions reductions plan. I anticipate that these documents will be published on the Ministry's website by the end of August 2024, and I am therefore refusing your request under section 18(d) of the Act.

Please find **attached** a list of documents that are being proactively released. Where documents will be released in part, we have indicated which grounds of the Act some information is likely to be withheld under.
