Thank you for your email of 3 December 2022 to Christchurch City Council requesting the following under the Official Information Act 1982 (the Act):

This is a request for information under the Local Government Official Information and Meetings Act or the Official Information Act (whichever applies) related to the current investigation seeking information related to the Christchurch City Council's vote against a plan change that would have enabled medium density residential development across the city. The Terms of Reference for the investigation required the investigator to work with the Council, MfE and MHUD to confirm a project plan not later than 25 November. Please send us a copy of that project plan as soon as practicable, as required under the Acts. Given the plan has already been agreed and the investigation has commenced, we trust a quick response will be possible.

On the 6 December 2022, the Ministry for the Environment (the Ministry) accepted transfer of your request. The Ministry also accepted transfer of a duplicate request under the Act from the Associate Minister for the Environment, Hon Phil Twyford.

The Ministry has identified the project plan for the Investigation of Christchurch City Council's non-notification of Intensification Planning Instrument, version 1 as in scope of your request.

Some information in an attachment to the project plan has been withheld under section 9(2)(g)(i) of the Act to maintain the effective conduct of public affairs through the free and frank expression of opinions by officers of any public services agency in the course of their duty.

The Ministry notes that the information in the two other attachments is already publicly available. The two other attachments are listed below with links to where the documents can be found on Christchurch City Council's website:

We are releasing the version of the project plan that was provided to the Ministry for the Environment in December 2022. This version doesn't include updates to reflect changes to meeting dates. The Ministry for the Environment has not received an updated version of the project plan.

The changes to meeting dates were made outside of Mr Hardie's control and were due to a Council meeting being moved and determining an appropriate time to meet with Te Rūnanga o Ngāi Tahu.

Mr Hardie presented at two webinars, hosted by the Council on Wednesday 14 December 2022. Timeframes for the investigation and Plan Change 14 were discussed during the webinars. 1 Context

1.1 Background

All specified territorial authorities were required by the Resource Management Act 1991 (RMA) to notify an IPI on or before 20 August 2022 to:

- give effect to the National Policy Statement on Urban Development 2020 (NPS-UD)
- implement the medium density residential standards (MDRS).

IPIs are required to be made operative using the Intensification Streamlined Planning Process. Christchurch City Council staff developed a draft IPI and consulted the public from 11 April to 13 May 2022. A final draft IPI was recommended to the Council for its approval to publicly notify. The previously elected Council made a decision at its 8 September 2022 meeting not to notify the draft IPI and to write to the Minister for the Environment.

On 20 September 2022, former Mayor, Hon Lianne Dalziel wrote to the Minister for the Environment (the Minister), Hon David Parker, to advise the Minister that the Council is aware it is in breach of its statutory obligations and to request that the Minister work alongside the Council to find a bespoke solution for housing intensification in Christchurch.

A new Council was elected following local government elections on 8 October 2022. On 27 October 2022, the Minister decided to initiate an investigation under section 24A of the RMA.

1.2 Investigation

The Associate Minister for the Environment, Hon Phil Twyford with responsibilities for urban policy appointed John Hardie to lead the investigation.

The purpose of this investigation is to consider the performance by Christchurch City Council (the Council) of its functions, powers or duties in relation to notifying an intensification planning instrument (IPI), as required by section 80F of the Resource Management Act 1991 (RMA).

The investigation will seek to understand the Council's perspectives in relation to the notification of an IPI, and the process for the Council making decisions on notifying an IPI. If potential next steps to make progress emerge, these will be deemed in scope.

2 Project Objectives

2.1 Project scope

The investigation will be focused on identifying and understanding the issues, the Council's perspectives in relation to housing intensification in Christchurch, and the notification of an IPI. Noting the previous Council's decision on the matter and that a new Council has been elected, the investigation will consider the following:

- the process for the Council to make decisions on notifying an IPI
- the views, issues and concerns the Council has about the draft IPI and the changes proposed to the operative Christchurch District Plan
- the perspective of Ngāi Tahu as Treaty partner and mana whenua
- the views of any key stakeholders if the investigator thinks that is necessary for him to carry out his functions.

If potential next steps to make progress emerge, these will be deemed in scope.

2.2 Project specific goals

The investigator will:

- in the first five days of the investigation, prepare this project plan
- hold interviews/workshops as he deems necessary with staff and the Council about the draft IPI
- seek the views of Ngāi Tahu as Treaty partner and mana whenua
- seek to understand any barriers to notification of an IPI
- complete a draft independent report, reporting on issues referred to in the appointment, and including recommendations for the Minister on the options for addressing any issues identified in the investigation (if needed).
- finalise and present the report to the Minister.

Ministry for the Environment officials will:

- prepare a template for findings and background material
- support the preparation of the report
- provide legal and communications assistance.

Christchurch City Council Officers will:

 Engage with the Investigator on the draft IPI, the process for the Council's decision on notification, and otherwise assist in enabling his consultation with Councillors and Mana whenua.
