Thank you for your email of 22 February 2024 requesting the following under the Official Information Act 1982 (the Act):

Can you please provide us with any information and documentation in relation to:

- Waikato Regional Council Global Contracting Solutions application for resource consent to build a waste incinerator at 401 Racecourse Road, Te Awamutu
- Waipā District Council Global Contracting Solutions application for resource consent to build a waste incinerator at 401 Racecourse Road, Te Awamutu
- Any correspondence between MFE and any iwi group and Waikato Tainui in relation to the above two applications.

The Ministry for the Environment (the Ministry) has identified 16 documents in scope of your request, as listed in the attached document schedule. Seven documents are being released to you in full. Three documents have been withheld in full under the following section of the Act:

9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials.

The six remaining documents have been released to you in part with some information withheld under the following sections of the Act:

9(2)(f)(iv)	to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials.
9(2)(h)	to maintain legal professional privilege.
9(2)(a)	to protect the privacy of natural persons, including that of deceased natural persons.

The Ministry received information from the Waipa District Council relating to the waste incineration proposal that is publicly available on the council website, available here: https://www.waipadc.govt.nz/our-services/planning-and-resource-consents/notified-resource-consents/waste-incineration-plant-proposal-401-racecourse-road-te-awamutu

During the assessment of the emails in scope of your request, there were a number of emails that were purely administrative in nature, such as organising meeting times, requests to print documents, meeting invitation responses, forwarding the same information to different people, and assigning or reviewing document requests. We have excluded these purely administrative

emails as out of scope as they do not provide any substantive information to you. If you decide that you require these purely administrative emails, we welcome you to submit a new request under the Act.

In terms of section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: www.ombudsman.parliament.nz.
