Please write your answer here: Far North Holdings Limited wishes to proceed with the development of Mangonui Wharf, the primary wharf in Northland serving the inshore fishing fleet. The project provides critical service infrastructure to the inshore fishing fleet. It also enhances public amenity values and uses. What are the project details? Please write your answer here: The project will have significant regional benefits and will support primary industries, including aquaculture. The development proposes a 50m extension of the main wharf providing the same with berthing space and 750m2 of wharf deck space. In addition, a 70m pontoon on the inside of the wharf will serve to service a number of smaller vessels in the fleet. Mangonui Wharf was in part built in the 1950s and has been one of the busiest commercial wharf facilities outside of Whangarei. The fishing industry is a significant contributor to the district economy and Moana New Zealand are an integral part of the development. Moana holds a 10-year lease over part of

The proposed development includes the provision of berthage and wharf space that will improve the efficiency of the fishing fleet and provide greater speed to market of catch. It provides an opportunity for small processing facilities and/or commercial retail experiences.
