Kia ora,

We don't know of any reason that this one would be ineligible.

A few points to note:

The project site is located within the Hicks Bay Unit 2 Outstanding Natural Landscape as identified in the Tairawhiti Resource Management Plan. Te Araroa Beach Ridges is classified as an extremely well defined landform of scientific/educational and scenic value. Karakatuwhero River and Te Whare Wetlands which are part of the project site are classified as regionally significant waterbodies.

The applicant would likely require a permit under the Wildlife Act as the project site includes habitat for shore skinks (which are classified as At Risk).

Regarding Treaty settlement matters, Pōtikirua ki Whangaōkeno Takutai Kaitiaki Trust have an application to the High Court under the Marine and Coastal Area (Takutai Moana) Act 2011 (MACA) to have Customary Marine Title recognised over the project area. Given the confidentiality requirements of this process, we have not been able to engage with our Treaty partners or address our obligations to give effect to Treaty principles. We recommend engagement with the Treaty partners to fully understand their perspectives.

A previous application for a barge facility made by Te Rimu Trust in 2022 under the COVID-19 Recovery (Fast-Track Consenting) Act 2020 was jointly declined by the Minister for the Environment and the Minister of Conservation.
