Identified potential ecological effects:

- Vegetation clearance including modifications to and near natural inland wetlands –habitat for critically endangered Matūku Hūrepo – Australasian Bittern. Works proposed are during breeding season. Impact on tuna habitat.
- Earthworks – excavation, potential impact on lizards/skinks, noise, vibration, threatened coastal plants
- Water quality – earthworks, stormwater runoff, sediment, discharges impact freshwater species such as whitebait, smelts, bullies, flounder, koura,

Permissions which may require DOC approval:

- Wildlife Act 1953 (such as aquatic ecology monitoring, handle, salvage and relocate protected wildlife, research and collection, native species monitoring)
