Kia ora e Karen

As far as we can ascertain, there is no public conservation land directly affected by this proposed water supply intake and reservoir at Poad's Rd near Levin. Accordingly, we are not aware of any reason for the project being ineligible for Fast Track consideration for that reason.

There is a track maintained by DOC across private land immediately to the east, providing access to the nearby Tararua Forest Park and car park for those visiting the area on the adjacent public road.

Due to the water supply intake to the reservoir being located in the river bed, freshwater fishery approvals may be required. There is also the possibility of wildlife habitat in the vicinity which may require Wildlife Act approvals.

We are not aware of any relevant Treaty considerations for this site, although there are settlement overlays in relation to the upper catchment managed by DOC which provides water to the location via the Ohau River.
