Paewira - Cultural Engagement Summary and Timeline

Cultural Guidance

Global Contracting Solutions Limited ("GCS") has been receiving advice from Professor Tom Roa who is a well-respected kaumatua and Waikato University academic, in relation to cultural matters concerning the project. Since the project's inception, Professor Roa is a relative of Mr Craig Tuhoro who is the owner of GCS. Professor Roa and Mr Tuhoro are both of Ngāti Maniapoto and Ngāti Apakura whakapapa.

Engagement Activity

Professor Roa facilitated and provided advice concerning engagement with iwi, marae, and Ngā Iwi Tōpū o Waipa ("NITOW"). That engagement is summarized in the below timeline. The timeline does not include all correspondence or conversations relating to engagement just the main interactions. There were also two site visits with representatives of NITOW.

Cultural Impact Assessment

In 2022, we engaged two separate people to conduct a Cultural Impact Assessment ("CIA") for Paewira under the guidance of Professor Roa. Those engagements were not able to be completed. We are still seeking opportunities to compete that work and to engage with iwi, hapu, and marae about the project.
