I won't be able to provide too much information for privacy reasons, but please see the attached.

There are 212 registered orchards situated on the given roads.

Please note that a new CRM system was implemented in March 2016, so we can't easily hone in on the establishment/registration date of an orchard prior to this date (March 2016 is the data migration date).

For questions relating to the kiwifruit workforce on orchards, you'd be best to reach out to NZKGI (New Zealand Kiwifruit Growers Incorporated), or a post-harvest facility.

Apologies I couldn't be a whole heap of help, but let me know if you have further questions and I'll answer what I can.

Good afternoon Zespri,

Trust this finds you well. I am wondering if you are able to provide me with information about orchards that have come online, to Zespri's knowledge via exporting, in a geographical area. The area is Pongakawa, east of Paengaroa and Te Puke. If possible, can I please get the following data:

- Orchards that have been established between 2012 and 2022 to date, the date of establishment/first export, with addresses at the following roads (all would have the locality/suburb name of Paengaroa, Pongakawa or Pukehina):
 - Pongakawa Bush Road;
 - Pongakawa School Road;
 - Pongakawa Station Road;
 - Old Coach Road;
 - Allport Road;
 - Maniatutu Road;
 - Benner Road;
 - Rotoehu Road;
 - Pukehina Station Road;
- Operating hectares of the orchards identified through the exercise above, as at 2022.

Appreciate some of this may have been supplied to the director here via a separate enquiry – not sure about the date information as requested.

Separately, is anyone able to point me to the average permanent worker/manager per hectare (i.e. full time employee, excluding pickers in the picking season) on the average kiwifruit orchard?

Lastly, if there is salary information for full-time employees of kiwifruit orchards (again, not seasonal pickers), that would be much appreciated.

Any feedback on these points at your earliest convenience would be much appreciated.
