This listed project application is for FTA237 – Waikaka Gold Mine.

The purpose of the project is to operate an open-cut gold mine over 8 years on a 95ha site, producing on average 6,000 ounces of gold per year.

The Applicant has undertaken extensive exploration, feasibility studies and commissioned relevant technical investigations over a number of years in order to determine the commercial and environmental appropriateness of the project. Extensive pre-application consultation has been undertaken with landowners, neighbours, the two consent authorities, government and iwi organisations, and the local community.
