#### Hi Stephanie

Please find following the DOC feedback on these three small hydro projects in central and south Westland, to the extent that the application provides relevant information. Some details would require more specific information.

As advised below, there are DOC administered lands involved in each case which either have or will require concessions through Fast Tracking. It is not clear if Wildlife approvals may be required, but freshwater fisheries matters may need to be addressed depending upon the nature and location of the diversion structures and what species are present.

No specific Treaty commitments have been advised in relation to these applications, but all would require engagement with the appropriate Ngāi Tahu authority.

As far as we can gather, there are no reasons for these projects to be ineligible for Fast Track consideration.
