Hi Neil

Here's the local feedback on this application. I don't see anything (within our area of interest) that would make it ineligible.

The application site does not involve any public conservation land and the areas directly affected are currently managed as plantation forestry and pasture for grazing.

There is a conservation covenant over part of one of the adjoining properties 9(2)

. The covenant is under the Reserves Act and protects an area of native forest and adjoining land that is being actively restored to forest. I understand the landowner is currently in discussions with the QEII National

Trust about covenanting more of her property with them. The application for the York Valley Landfill won't have any direct effect on the covenanted area, but there would be potential indirect cross-boundary effects, e.g. from wind-blown rubbish or by the landfill acting as an attractant for pest animals. These effects would be similar to those already occurring with use of Gully 1.

Out of Scope

We have no records of protected wildlife on the application site, but there is a record of northern spotted skink on one of the adjacent properties. That or other lizard species may be present within the application site and a Wildlife Act authority may therefore be required to survey the site and carry out any translocations that would be required.

Discharges from the project have the potential to affect water quality in the York stream, which is a tributary of the Maitai River, and will need to be well managed. Again, these effects will be similar to those already occurring with use of Gully 1.

The Maitai (Mahitahi) River and its tributaries are subject to statutory acknowledgements for Ngāti Kuia, Rangitāne o Wairau, Ngāti Kōata, Ngāti Rārua, Ngāti Tama ki Te Tau Ihu, Te Ātiawa o Te Waka-a-Māui and Ngāti Toa Rangatira. There are no other Treaty Settlement obligations over the application land.

There are no registered archaeological sites on/adjacent to the application land.
