Hi Steph

As requested, please see the following comments from the DOC district office, regarding project application FTA101 Macraes Phase Four (MP4):

1. There is no Schedule 4 land, in respect of clauses 18(f) and (h) of the Fast-track Approvals Bill, that would render the project ineligible.
2. Presence of native lizard populations and as such would require a separate approval, in the form of a Wildlife Authorisation, for any disturbance to lizards.
 - o Please note, DOC has recently received a WA application from the applicant.
3. Presence of archaeological sites and as such would require a separate approval in the form of an Archaeological Authority from Heritage NZ Pouhere Taonga.
4. It is a standard Ngāi Tahu Claims Settlement Act 1998 protocol area. The views of Ngāi Tahu would be needed to confirm that the settlement was being upheld.
5. Within the vicinity of the 'Coronation North' site is a DOC RAP (Recommended Area for Protection).
6. Presence of threatened native non-migratory galaxias fish species may require fishery approvals if habitat is affected.
7. Public Conservation Land, namely Golden Point Historic Reserve, Deepdell Creek Conservation Area, Murphys Flat Historic Reserve present within the applicant's wider Crown Minerals Permit. Whether concessions or a land access arrangement are required for these is not entirely clear.

Additional note: There have been concerns raised within DOC and local councils, regarding the applicants' compliance issues with existing consents/permits.
