Q1 Project location

A The location of the project is yet to be confirmed, however Sanford can report that it has shortlisted three potential sites and due diligence on all three sites has been undertaken. Due diligence includes analysis of the site suitability against a matrix of requirements, conditions of any existing consents (where they exist), scoping of required RMA consent requirements and regional regulation, and water testing with a relevant and sensitive biological assay. For one of the three potential sites, a resource consent application has been lodged and accepted under s88, and Sanford is supporting the applicant to prepare its s92 Further Information response. The location of the three sites is commercially sensitive and will only be disclosed with a confidentiality agreement due to the sensitivity (scarcity) of suitable spat hatchery sites around New Zealand's coastline.

Q2 Record of title

A In each case the potential site is on freehold title that is owned by another party. The other party is aware and in agreement with Sanford's plans for a potential hatchery build.

Q3 Nature of Sanford legal interest

A Sanford will have a legal, long term lease agreement on the land, and Sanford will own some or all of buildings and plant. In some cases the water take and discharge permit will be owned by land owner and managed by Sanford. Sanford will own the intellectual property and will likely have a third party co-investor (these discissions are underway)
