APPLICATION STRUCTURE

This application document is in support of applications by OceanaGold (New Zealand) Limited ("**OGNZL**") for resource consents from Waikato Regional Council ("**WRC**") and Hauraki District Council ("**HDC**") under the Resource Management Act 1991 ("**RMA**") to authorise all necessary activities associated with the Waihi North Project ("**WNP**").

All matters required to be addressed in accordance with Schedule 4 of the RMA are contained within.

This application comprises 11 parts as follows:
