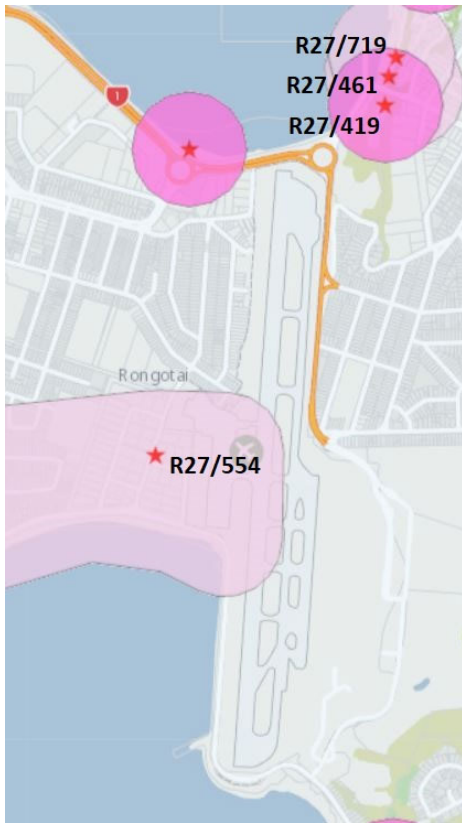
*We need to know what, if any, PCL is directly affected by the project and the status of that land, to confirm it is not ineligible.*

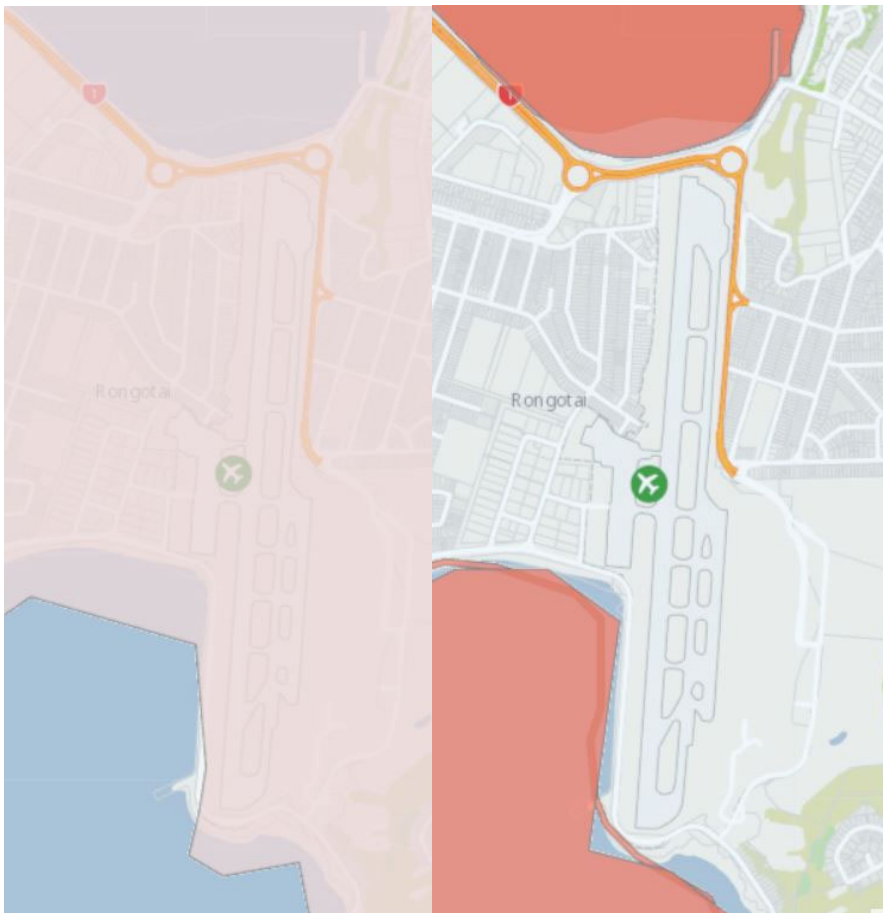
- Summary of DOC Treaty map layers below. Land proposed to be potentially acquired is private.
