Kia ora Steph,

We don't know any reasons why this project would be ineligible. There is no PCL within the project area, although the site is immediately north of Te Maketu Historic Reserve. We haven't identified any further wildlife issues beyond the need for Wildlife Act and Conservation Act approvals as indicated in the application.

Treaty settlement redress in the project area:

- Ngāti Tamaoho – Conservation Protocol Area, Statutory Acknowledgement. Also a Deed of Recognition over the nearby Te Matuku Historic Reserve.
- Tāmaki Collective – Conservation Protocol Area, Right of First Refusal.
- Ngai Tai ki Tāmaki – Conservation Protocol Area.

Kia ora Meredith –

We have gathered together the information you were seeking as follows:

We need to know whether any PCL which is out of scope of Fast Track is in the project area, such as National Park, Wildlife or Forest Sanctuary, Nature or National Reserve, or Ramsar site.

There is no PCL within the project area.

As wider context the site is immediately north of the Te Maketu Historic Reserve (which comprises three blocks).

It is also helpful to know if there are other potential issues affecting wildlife for which approvals will be required under this application, although those may not be grounds for ineligibility ie. any DOC-related

approvals that would be needed (they have already indicated the need for Wildlife Act and Conservation Act approvals).

We have not identified any other potential issues affecting wildlife, that would be in addition to permits required under the Wildlife Act.

Secondly, please advise if there are any Treaty settlements relevant to the project site. We don't need to contact the Treaty partner (due to confidentiality) but do need to advise our colleagues at MfE running the eligibility assessment if this is a potential risk for eligibility and upholding Treaty settlements.

There are no areas of PCL that have been returned to iwi as Treaty settlement redress within the project area.

As broader context the DOCGIS Treaty layer identifies the following Treaty settlement redress that includes the project area:

- Ngāti Tamaoho – Conservation Protocol Area, Statutory Acknowledgement. Also a Deed of Recognition over the nearby Te Matuku Historic Reserve.
- Tāmaki Collective – Conservation Protocol Area, Right of First Refusal.
- Ngai Tai ki Tāmaki – Conservation Protocol Area.

Kia ora,

We have a schedule 2A mining application from Stevenson Aggregates Ltd for their Drury Quarry Expansion – Sutton Road Block (FTA161 –the files are available to view on our Teams private channel). They are seeking to establish a new quarry on land adjacent to their existing quarry.

The applicant indicates the need for a Wildlife Authority for the salvage and relocation of protected species and for unintentional deaths of protected species, and authority under the Conservation Act 1987 to transfer and release freshwater aquatic life.

The project is within the areas of interest specified in the relevant Treaty settlements between the Crown and the following iwi/groups: Ngāti Tamaoho, Ngāi Tai ki Tāmaki, and the Tāmaki Collective. The site falls within the area of interest of Ngāti Paoa, as specified in the Deed of Settlement between Ngāti Paoa and the Crown. Additionally, the project site is within the collective area of interest within the Marutūāhu Collective Redress settlement, which concerns the collective interests of Ngāti Maru (Hauraki), Ngāti Tamaterā, Ngaati Whanaunga and Ngāti Paoa (whose individual areas of interest include the project site), and Te Patukirikiri (whose area of interest does not include the project site).

Could you please let us know anything you're aware of that would render this project ineligible under Clause 18, or any relevant Treaty settlement issues you are aware of. We'd be grateful if could you provide any feedback by **5pm Friday 7 June**.
