We are not aware there is any public conservation land within this project area; nor does there appear to be any such land immediately adjacent.

The applicant acknowledges that they have no wildlife or fisheries assessments but that these are being commissioned. There are some significant areas of potential habitat within the project area, as follows:

- Long-tailed bats (Threatened Critically Endangered) have been recorded less than 12km east and to the north and south, so should be considered highly likely to be present.
- The area is a known flyway for South Island pied oystercatchers (Declining). See attached image.
- Records from tracked bittern (Threatened Critically Endangered) see attached map do not pass through the site. However, this site lies between areas of known bittern habitat on the west coast and the lakes and wetlands around Huntly.
- Other highly mobile species are likely to pass through this area for the same reasons. This includes white heron (Threatened Nationally Critical), Caspian tern (Threatened Nationally Vulnerable), royal spoonbill (Naturally Uncommon) and migratory species moving between the South Island and northern feeding grounds.

None of this are grounds for ineligibility of the project but does suggest it may not yet be ready for Expert Panel consideration.

The project area is within the scope of the Waikato-Tainui Raupatu Claims (Waikato River) Settlement Act 2010. No public conservation land is included within the project area, so co-management agreements do not apply. Co-management of the river (and its tributaries) does apply, however. We would advise that Tainui and relevant hapū are consulted for their views on the project and whether it would uphold their settlement.
