Hi Jekabs

The proposed structures and amendment to the staircase area will require at approval through either an EPA or approval from the Chief Engineer at AT. My team will not lead this process but its good to keep me involved for when the fast track application is lodged.

- In term of encroachments, the fast-track referral application document wasn't clear on the proposed and required retaining structures for the building itself (and to a lesser degree for the proposed access). Encroachment licence should not be required for the retaining structures proposed to allow vehicle access, this will however need AT approval (see below bullet point). In terms of the retaining for the building/the buildings interface with the staircase area, the applicant will need to establish if an encroachment licence is required. Please refer to AT encroachment guidelines https://at.govt.nz/media/1985549/guidelines-for-road-encroachment-licences-24-february-2021.pdf. You can also contact the AT property team to arrange a encroachment licence pre-app consultation or submit an application for an encroachment licence if one is required. propertygroup@at.govt.nz
- The applicant will need to apply for EPA or obtain approval from the Chief Engineer at AT (through means of an Asset Owner Approval process Consent from AT as landowner) for proposed works/structures and amendments in the road, taking into account AT's requirements and design standards (also noting the proposed departures from AT's standards by removing a footpath(staircase) from one side of the road).
 - I discussed this with our Design and Standards Team and I have been advised that the preferred route would be to apply for an Engineering Plan Approval pre-app through Auckland Council which should advice on AT's requirements before formal Engineering Plan Approval is submitted for the proposed works.
