COVID-19 Recovery (Fast-Track Consenting) Act 2020 – comments sought on referral applications – Flints Park West and Glenpanel, Ladies Mile – Te Pūtahi

The Minister for the Environment (the Minister) received applications to refer the following two projects to an expert consenting panel (a panel) for consideration under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (FTCA):

- 1. Flints Park West from Glenpanel Development Limited
- 2. Glenpanel, Ladies Mile Te Pūtahi from Maryhill Limited.

The purpose of the FTCA is to promote employment to support New Zealand's recovery from the economic and social impacts of COVID-19 and to support certainty of investment while continuing to promote the sustainable management of natural and physical resources.

The projects are described in Attachment A and copies of the application documents are electronically attached.

You may have an interest in the projects because they are expected to have effects on the local roading network. Under delegated authority from the Minister and pursuant to section 21(3) of the FTCA, I invite you to provide written comments on the referral applications. A template is attached for this purpose.

The above information is provided to you in confidence and as part of the statutory process set out in the FTCA. Please do not forward the applications or request for comments to anyone outside your organisation.

If the Minister accepts the applications and the projects are referred to a panel (or panels), the applicants will be able to lodge applications with the Environmental Protection Authority for the approvals needed under the Resource Management Act 1991. The applicants must provide a detailed assessment of environmental effects and cultural impact assessment(s) as part of this process.

Please provide your comments via return email within 10 working days to ensure that the Minister takes your comments into consideration when deciding whether or not to accept the referral applications. Note that the Minister is not required to consider any comments provided after this time.
