#### Hi Jacob

We wanted to touch base on a couple of matters relating to the referral application for the above matter lodged on 21 February 2023 as per the confirmation email below.

Firstly, Heritage New Zealand Pouhere Taonga has now provided the archaeological authority that was applied for by The Foundation Village Partnership, and referred to in the referral application. A copy of the authority is **attached**. Are you able to pass this on to the analysts reviewing this application please?

It has also been brought to our attention that there has been a transcription error relating to the height of the proposed building in the assessments submitted in support of the referral application. The Peddlethorp drawings contained in Attachment 4 to the application show a proposed total building height of 49m including all plant/lift. The bulk and mass visuals included in Attachment 4 to the application, and all other assessments included in the referral application, were based on this proposed height of 49m.

However, unfortunately there was a transcription error in an early draft document with respect to this figure, such that the text in the body of supporting assessments inaccurately refers to '42m' rather than the correct figure of '49m'. We are bringing this matter to the fast-track team's attention so that the analysists can be made aware of this discrepancy; however, we can confirm that it does not affect the content of the assessments that were prepared in support of the application in any way, as the drawings and visuals upon which the assessments were made show the correct proposed height of 49m.

Please let us know if there is any additional information required, or any further queries that the analyst team has, at this stage.
