Hi Nick,

My apologies for the delay in responding due to several priorities at work and meeting with Ngati Toa.

Morphum Consultants conducted the sewer network capacity assessment in 2019 based on the projected population growth at the time. Earlier this year Council adopted a revised growth strategy Te tupu pai, Growing Well. The Strategy anticipates higher levels of growth for the district over the next 30- years, and sets out the vision for the shape of growth, both up and out. The Strategy has subsequently informed District Plan Change 2, which seeks to enable intensification of development in line with NPS-UD and MDRS requirements.

Since Morphum's assessment was completed, several planned and unanticipated developments have come forward, including the impact of extreme wet weather and changing network loadings across <u>the sewer network and</u> treatment plants.

Increased population projections and the potential impact of Plan Change 2 on where growth might occur means the assessment work completed by Morphum has now lost its relevance for most of the district.

As a result, KCDC is looking to update and review network capacity as part of LTP 2024. The proposed update shall include verifying and calibrating the sewer network simulation model, treatment plant capacities and resource consent. This information will enable us to update plans and assumptions for future growth, including development contributions. Until that work can be completed, and to keep the momentum of the development, KCDC is reviewing the network capacity required for new development on a case-by-case basis.

Happy to have an open and frank discussion about enabling the proposed development in a sustainable way.

Kia ora Ramesh,

Thank you for your time on the phone this afternoon. As I mentioned we have been working with Thushan to determine the constraints for the development of the above site, see a high level overview plan **attached**. As part of this, and in partnership with the developer, Council have commissioned HAL to complete modelling and an assessment of the wastewater network. I understand that Morphum (with HAL) have completed an assessment of the wider network, and that from our conversation that you are happy for us to be sent a copy. S 9(2)(a) can you please arrange for this to be sent through to me? Can you please also provide advice on the implementation of any recommended upgrades, and where these sit in terms of the Long Term Plan funding allocation? We note also that Council have received a significant funding contribution from Kāinga Ora, and I understand that some of this will be allocated to the upgrade of the wastewater network.

We are seeking approval to proceed through the fast track consenting process. This process allows for significant iwi involvement, and we have been in discussion with Ngā Hapū o Ōtaki over the past 4-5 months regarding this development. Caleb Royal from NHoŌ has suggested this project could be used as an example for the implementaiton of the new stormwater management framework, which the development team are also in support of. We have also been engaging with Ngāti Toa and Muaūpoko, which is ongoing.

When assessing the referral application, the Minister for the Environment will likely want to understand Council's position on network upgrades that may be required to service the development. We understand that there are known capacity constraints, and although the modelling work is yet to be completed, anticipate that some upgrade works will be required. We anticipate that these works will be facilitated through a development agreement, the detail of which (including cost allocation) will be determined once we have all the necessary information. I understand from our discussion today that the Kāpiti Coast District Council is willing (at a high level) to partner with the developer to facilitate the necessary upgrade works, noting that there is a significant amount of mahi to be completed before we understand what the implementation looks like. Can you please confirm this position?

Note that the above calc includes the recently constructed lifestyle village but does not include any industrial land, which is a significant catchment.

Like you, we are keen to understand the network so we can progress discussions on servicing the site. Can you please confirm if you will engage with HAL and Stantec to confirm the cost and timing for the wastewater and water modelling required? Or do you want us to do this directly and copy you in? In the past, KCDC have engaged the modellers directly and passed the costs on to the developer. Barber Commercial are currently reviewing the layout, which we anticipate issuing next week, or early the following week. It would be good to get the pricing etc underway ahead of this if possible – let me know how you want to go about this.

Here are some details from a 2006 report that shows the sectional area at 2.54m2 so that would make the wet well a 1.8mtr diameter chamber. This only provides 7.21 m3 storage in the wet well so it's a very small pump station.

The existing pump capacity is around 10l/s(from available information and needs to be verified). The hydraulic model analysis is required to assess the improvement of the pump station capacity and downstream network due to new development.
