FTC#190: Application for referred projects under the COVID-19 Recovery (Fast-track Consenting) Act 2020 – Stage 1 decisions

Key messages

- This briefing seeks your initial decisions on applications to refer the following projects to an expert consenting panel (a panel) under the COVID-19 Recovery (Fast-track Consenting) Act 2020 (FTCA):
 - a. Summerset Rotorua Project, from Summerset Villages (Rotorua) Limited
 - b. 33 Main Highway Project, from Wakefield Group Holdings Ltd.

Summerset Rotorua Project

- 2. The Summerset Rotorua Project is to construct and operate a retirement village and a separate commercial hub on an approximately 14.2 hectare site located at 171-193 Fairy Springs Road, Fairy Springs, Rotorua. The retirement village provides approximately 280 independent living units, 100 units comprising assisted living suites, memory care suites and beds, and resident indoor and outdoor facilities. The commercial building provides for activities such as medical facilities, childcare, café, and convenience retail. The project includes separate parking areas for the retirement village and commercial hub, landscaping, stormwater management and temporary activities for staged construction.
- The project will require land use and subdivision resource consents under the Rotorua Lakes District Plan (RLDP), land use consent and discharge permit under the Bay of Plenty Regional Council Natural Resources Plan, and resource consent under the Resource Management (National Environmental Standards for Assessing and Managing Contaminants in Soil to Protect Human Health) Regulations 2011 (NES-CS).
- 4. The project is located in the Commercial Zone 5 City Entranceway Tourism (COMZ5) and in the Water Zone (where the Waiowhiro Stream traverses the site) under the Rotorua District Plan. The COMZ5 zone focuses on concentrating outdoor adventure tourism attraction (and supporting activities) along the northern and southern entranceways into Rotorua. The project site is the only COMZ5 zoned land on the eastern side of Fairy Springs Road.
- 5. The proposed activities would have overall non-complying activity status as they are retirement village and commercial activities on sites zoned for City Entrance Tourism. The applicant considers that the project is not contrary to the relevant objectives and policies of the RLDP, which the applicant considers will allow the project to pass the 'gateway tests' in section 104D of the Resource Management Act 1991 (RMA).

33 Main Highway Project

- 6. The 33 Main Highway Project is to develop an approximately 4.6 hectare site located at 33 Main Highway, Ōtaki to subdivide land and construct approximately 143 residential units (stand-a-lone and semi-detached), and supporting infrastructure including roads, vehicle and pedestrian and cycle accessways, car-parking areas and three-waters services.
- 7. The project will require subdivision and land use consents under the Kāpiti Coast District Plan (KCDP), land use consent and discharge permits under the Greater Wellington Proposed Natural Resources Plan and land resource consent under the Resource Management (National Environmental Standards for Assessing and Managing Contaminants in Soil to Protect Human Health) Regulations 2011 (NES-CS).
- The project is located in the General Residential Zone under the KCDP. This zone identifies urban areas where residential activities are the primary activity. The zone generally has low density and detached built form.

9. The proposed activities would have overall non-complying activity status under the KCDP due to the density of residential subdivision and development. The applicant considers that overall, the project will not be contrary to the relevant objectives and policies of the KCDP, and that adverse effects can be mitigated so they will be no more than minor, which the applicant considers will allow the project to pass the 'gateway tests' in section 104D of the Resource Management Act 1991 (RMA).

Analysis of Projects

- 10. We have undertaken an initial (Stage 1) analysis of the referral applications and this is presented along with our recommendations in Table A.
- 11. The projects meet all the eligibility criteria in section 18(3) of the FTCA, but more analysis is needed before we can advise you if they meet the purpose of the FTCA (thus satisfying section 18(2) of the FTCA) and advise you on matters in section 23(5) which may influence your referral decision.
- 12. We recommend you progress consideration of both applications to the next stage of analysis (Stage 2) and invite comments from the relevant local authorities and specific Ministers listed in section 21(6) of the FTCA.
- 13. We recommend that for the Summerset Rotorua Project, you invite comments from the Minister for Seniors as an additional Minister under section 21(6)(n) of the FTCA, and Waka Kotahi NZ Transport Agency (Waka Kotahi), Kiwi Rail, and Lakes District Health Board as additional parties under section 21(3) of the FTCA.
- 14. We also recommend that for the Summerset Rotorua Project you request further information from Rotorua Lakes District Council as detailed in Table A.
- 15. We recommend that for the 33 Main Highway Project, you invite comments from Waka Kotahi as an additional party under section 21(3) of the FTCA.

Statutory framework summary

- 16. You are the sole decision maker for the referral applications as the projects will not occur in the coastal marine area.
- 17. You may decline a referral application before seeking comments from the relevant local authorities and any relevant Ministers:
 - a. if you are satisfied the project does not meet the referral criteria in section 18 of the FTCA, (which include helping to achieve the purpose of the FTCA) (see sections 18(2) and 23(1) of the FTCA)
 - b. for any other reason (see section 23(2) of the FTCA).
- 18. If you do not decline a referral application at this stage:
 - a. you must provide the application to, and invite comments from, the relevant local authorities and the relevant Ministers prescribed by section 21(6) of the FTCA
 - b. you may provide the application to and invite comments from any other person.
- 19. You are also able to request further information from the applicant or any relevant local authority at any time before you decide to decline or accept a referral application (see section 22 of the FTCA).
